Kris Hart Introduces sixth proposed Congressional Bill: Enough is Enough. Let's Stop the Pain, Loss and Carnage Now!

Philadelphia and Montgomery County, Pennsylvania – Kris Hart is coming out with a strong and aggressive proposal to end this senseless violence. “Enough is enough. I am so tired of waking up to or hearing these tragedies. How many people have to die? This is crazy and unacceptable. Action needs to happen and the time is not now, it was ten years ago. I am so sad,” said Hart.

The Team Hart campaign released their sixth proposed Congressional Bill today after the devastating news at a High School in Florida yesterday. “We are all devastated and we need our leaders to offer solutions. I am so sad, frustrated and upset. Where are our leaders?,” Hart said. “I know this will not bode well with my Republican base but I do not care; as a public servant it is my job to stand up for security and safety of our children, families, friends and neighbors. Enough is enough. We have to address the mental health issues, the bullying, and the ease of one’s ability to obtain a dangerous and unnecessary gun.”

“When I went to adopt my two rescue puppies, one who was abused and one who was abandoned, both I love to the moon and back, I had to wait two weeks through the process. I went through a personal background check, a home walk through, a criminal background check, a financial background check, and about 80 questions over two hours in an interview. All to rescue two little puppies I love so much. Jade was used as a fighting dog in Alabama and escaped in the floods; Mr. Trooper was abandoned a week old and was in a kill shelter in Virginia. Two weeks. When my Dad went to buy a gun in December to protect his home, granted he has no criminal record, it took him 5 minutes at a gun show. 5 minutes. 17 young people died last night. Does this make sense?,” Hart said frustrated. “I believe in the Second Amendment, but this is devastating, unacceptable and happening way to often. We have to do something now. It needs to stop now. Let’s do everything we can to end gun violence Now!”

Candidate Kris Hart will release many more proposed Bills for action in the coming weeks. Kris just released his first “Candid Conversations with the Candidate” and said he looks forward many more and to “open Civil Discussion and pursuing his Civic Duty.”

Mr. HART introduced the following bill; which was referred to the Committee of the Whole and the Committee on Homeland Security.

A BILL

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

This Act may be cited as the “To Respect the Right for Law-Abiding Americans to Responsibly Carry Guns that have a Lawful and Safe, Meaningful Purpose while Protecting Innocent Citizens from Tragedy (Responsible Act)”

SEC. 2. FINDINGS.

The Congress finds the following:

- (1) On average 96 innocent people are killed by guns every day. Approximately 13,000 innocent lives are lost to gun deaths a year.
- (2) In 2017 alone, there were 307 mass shootings (almost as many as days) in our beloved United States of America in churches, schools, clubs, streets, concert venues, etc.

- (3) Americans are more susceptible to be killed by gun violence than most leading causes of death.
- (4) The havoc and torment of gun violence and death affect hundreds of thousands of people in America every year.
- (5) Gun violence and the threat costs us millions of dollars every year to defend with police and security and response.
- (6) Law-abiding citizens with good intentions have the right to bear arms and their Second Amendment freedoms.

SEC. 3. IT IS THE RESPONSIBILITY OF THE GOVERNMENT TO WORK TO ENSURE THAT NO MORE INNOCENT LIVES ARE LOST, AND THAT PEOPLE ARE PROTECTED AND FEEL SAFE.

- (a) BE IT RESOLVED — No Individual may purchase a gun immediately. All purchases require a minimum of a two-week holding period.
- (b) BE IT RESOLVED — Every individual purchasing a firearm must undergo a home inspection, financial background check, a mental health background check and a questionnaire developed and administered by the local Alcohol, Tobacco and Firearms (ATF) of Federal Bureau of Investigations (FBI) before obtaining said weapon. It shall be approved by the Special Committee on Gun Responsibility.
- (c) BE IT RESOLVED — Any individual or company that violates this policy is subjected to a minimum of 1 (one) year in prison and a \$100,000 fine.
- (d) BE IT ORDERED — The Congress shall set up a Special Committee on Gun Responsibility, composed of two Members of the U.S. House of Representatives, two Members of the United States Senate, two representatives of the U.S. Department of Homeland Security, two big city Mayors, and two local Sheriffs to determine and make a recommendation to the Congress on the use, distribution and control of semi-automatic weapons and other dangerous weapons, which must be immediately made public. It shall be chaired by the U.S. Attorney General. The individuals on the committee will be jointly determined and appointed by the Chairman and the Minority Leader of the Committee of the Whole and made public. Their report is required within ninety (90) days of the passage of this Bill.
- (e) BE IT RESOLVED — That any law-abiding American Citizen shall have the right and freedom under the Second Amendment of the Constitution of the United States of America to bear lawful arms responsibly.
