

Summer Camp Policies 2018

- 1. Summer Camp space is limited to 15 children per week of camp. You must pre-register for CHS Summer Camps and payment is due in full at the time of registration via PayPal.
- 2. CHS Summer Camps 2018 will be based out of CHS's downtown TriCentennial Park complex (Georgia State Railroad Museum/Savannah Children's Museum/Savannah History Museum).
- 3. Summer Camp drop-off will take place daily from 8:45 AM 9 AM. Logistical information including details about drop-off and pick-up will be communicated to all registered families via email no later than one week prior to the first day of camp.
- 4. Due to the risk of food allergies, we ask that **absolutely NO PEANUT PRODUCTS** be brought to Summer Camp. This includes any peanut butter, snacks, or granola bars that contain peanuts on their ingredient list.
- 5. Lunch/snacks will not be provided for children. Every child must bring their own lunch/snacks from home every day of camp.
- 6. All participating children must be fully potty-trained.
- 7. All participating children should bring a backpack each day to camp that includes the following items with the camper's name clearly marked on each item: **sunscreen**, **bug spray**, **a water bottle**, **lunch**, **and a change of clothes**. A water re-fill station will be available to campers.
- 8. Please dress your child in clothes that can get dirty. Campers will be getting dirty at all of our camp offerings.



- 9. Time-out is the method of discipline to be administered. Any behavior relating to the safety or well being of any child or adult will result in immediate removal from Summer Camp. This includes biting, pinching, hitting, kicking, pulling hair, scratching, etc. Offensive language and bullying will not be tolerated. No refund will be issued in the event of child removal from Summer Camp for unacceptable behavior
- 10. Children with the following physical signs and symptoms may not be dropped off due to risk of exposure: diarrhea, temperature of 100 degrees or above, runny nose of any color, coughing, rashes including chicken pox and ringworm, conjunctivitis, or other signs of contagious or non-contagious illnesses. Your child must be fever-free for at least 24 hours before being left at CHS/SCM/GSRM. A refund of 50% of the child's Summer Camp fee will be refunded in the event of sudden illness, only with medical documentation.
- 11. A full refund will only be issued if CHS/SCM/GSRM is notified via email at least three weeks (21 calendar days) before the week of Summer Camp that you registered for begins.
- 12. Summer Camp Late Pick-up Policy: You will be charged \$1 per minute after 2:10pm. If your child is not picked up before 3:30pm, the police will be called to contact you and arrange pick-up from their facilities.
- 13. Non-compliance with the policies may result in suspension of privileges from Summer Camps. Your cooperation is greatly appreciated.
