Desert Ridge Marketplace reserves the right to modify or cancel an event at any time.

Policies and Procedures

1. Performance dates are available on a first come, first served basis. *The stage is NOT available Fridays & Saturdays from 7pm – 10pm. Bands typically set up at 5:00pm.* Please choose your performance date/time accordingly.
2. The shopping center is non-denominational, so please choose your music/topics accordingly. Religious and political content is not permitted. Content should be family-friendly.
3. You are performing on our stage at your own risk. By signing the attached hold harmless agreement, you are relieving Desert Ridge Marketplace/Vestar of all accountability and are accepting responsibility for any and all damages and/or injuries. Desert Ridge Marketplace is not responsible for lost or stolen items.
4. Should weather hinder your performance, you may reschedule your event based on availability.
5. Tip jars, flyer distribution and soliciting are not allowed.
6. If you would like to sell products or distribute information, you may do so **ONLY** with prior permission from the management office. We will be happy to provide you with an approved table, linen and chairs.
7. All display areas must be kept clean and set-up in an orderly fashion.

Power and Lighting

1. Power is located on the back side of the stage.
2. Additional power is available with spider boxes (available upon request).
3. Performers are responsible for providing their own extension cords.
4. Please note ***we only supply electricity, not equipment.***
5. Stage lighting automatically turns on each night at dusk.

Audio

1. We encourage you bring your own equipment; however, 2 microphones are available upon request.
2. Our speakers only run the microphone, PlayStation, amplifier (which runs iPod and iPhone) and video wall itself. Speakers will not amplify instruments.
3. Performers are responsible for providing and managing their own sound.
4. Audio needs must be confirmed 2 weeks prior to event.
5. Desert Ridge Marketplace staff will assist with initial sound needs. Please contact Security at 480-419-8101 once you are on site and ask for maintenance to meet you at the stage.
6. We do not allow sound levels over 90-95 decibels.

LED Video Screen

1. Images can be played on the large screen at the stage (along with other ads/music videos) during your event.
2. Still images must be submitted via email 2 weeks prior to event.
