- **APPLICATION** – MUST BE COMPLETED AND SIGNED BY BOTH PARENT/GUARDIAN AND STUDENT(S). INCORRECT OR INCOMPLETE APPLICATIONS CANNOT BE PROCESSED.
- **PAYMENT** – CREDIT CARD, CASH, CHECK, AND MONEY ORDER.
- **SIGNED BUS RULES** – SIGNED BY BOTH PARENT/GUARDIAN AND STUDENT(S).

After a bus pass is issued the student must keep their ID/Bus Pass on them at all times to ride the bus. Please locate and review the student handbook for rules on ID cards. If an ID/Bus Pass is forgotten the student(s) will be subject to a bus citation by the bus driver. If a student does not have an application on file and has not purchased a bus pass for the semester, are **not eligible to ride the bus for any reason.**

BUS RIDERS RULES

- ALL STUDENTS **MUST PURCHASE THEIR BUS PASS EACH SEMESTER** TO CONTINUE RESERVING THEIR SEAT.
- ALL STUDENTS WHO HAVE FORGOTTEN THEIR ID/BUS PASS **MUST REPLACE IT AT A \$5.00 CHARGE TO THE STUDENT.**
- ALL STUDENTS MUST RIDE ON ONLY THE **DESIGNATED BUS ROUTE AT THE DESIGNATED STOP.**
- ALL STUDENTS MUST ARRIVE AT THE DESIGNATED BUS STOP FIVE (5) MINUTES PRIOR TO PICK UP TIME.
- **NO FOUL/OFFENSIVE/INAPPROPRIATE LANGUAGE PERMITTED.**
- **NO DRINKING, EATING, OR CHEWING GUM.**
- **NO WEAPONS OR DANGEROUS OBJECTS ALLOWED ON THE BUS INCLUDING PERFUME/COLOGNES, ANY SCENTED SPRAY BOTTLES OR SPRAY CANS OF ANY KIND.**
- **DO NOT THROUGH ANY OBJECTS INSIDE OR OUTSIDE OF THE WINDOWS OF THE BUS/NO LITTERING.**
- **KEEP HANDS, HEADS AND ANY OTHER BODY PARTS INSIDE THE BUS AND TO YOURSELF.**
- **NO STANDING OR SWITCHING SEATS WHILE THE BUS IS IN MOTION. NO SITTING IN THE ISLE.**
- **NO SMOKING ON THE BUS OR NEAR DESIGNATED BUS STOPS.**
- **DON NOT VANDALIZE ANY PART OF THE BUS OR BUS STOP. YOUR BUS PRIVILEGES WILL BE REVOKED.**
- **NO FIGHTING/PLAY FIGHTING ON THE BUS OR AT THE BUS STOP. (AUTOMATIC DISMISSAL)**
- **DO NOT HARASS ANY STUDENT VERBALLY OR PHYSICALLY.**
- **NO PICTURES/VIDEOS CAN BE TAKEN ON THE BUS WITH A CELL PHONE, TABLET, CAMERA OR ANY MEDIA DEVICE.**
- **CALIFORNIA LAW STATES “WHENEVER SEATBELTS ARE AVAILABLE YOU MUST WEAR THEM.**
- **AUDIO AND VISUAL EQUIPMENT CAN BE USED BY THE STUDENT SERVICES DEPARTMENT **ONLY**.**
- **PARENTS MUST FOLLOW ALL APPLICABLE TRAFFIC LAWS – INCLUDING NEVER STOPPING OR CUTTING OFF A BUS’ PATH IN MOTION WHEN PICKING UP OR DROPPING OFF STUDENTS. PARENT’S DRIVING ACTIONS CAN ALSO JEOPARDIZE BUS PRIVILEGES FOR ALL STUDENT IN THE CAR.**
- **IF YOU ARE CITED BY A CHP OR SHERIFF’S DEPARTMENT ALL BUS RIDING PRIVILEGES WILL BE SUSPENDED.**
- **IF A STUDENT IS SUSPENDED FOR ANY REASON ALL BUS RIDING PRIVILEGES WILL BE REVOKED.**
- **IF FOR ANY REASON YOUR PRIVILEGES HAVE BEEN SUSPENDED OR REVOKED THERE WILL BE NO REFUNDS OF ANY FEES.**

IF THE RIDER HAS VIOLATED ANY ONE OF THE ABOVE RULES, HE/SHE MAY BE ASSIGNED A PERMANENT SEAT OR PRIVILEGES MAY IMMEDIATELY BE SUSPEND/REVOKE.
