All Payments Made Lease Program Form Requirement

Select States: NJ, NH, and WI

October 24, 2016

Hyundai Motor Finance (HMF) would like to remind our dealers that, effective October 24, 2016, the improvement to our early termination provision requires dealers to submit the All Payments Made (APM) Lease Program Form if a customer ends their lease more than 120 days from their scheduled maturity date (loyal and non-loyal customers).

To help ensure an overall positive customer experience, dealers will need to continue sending any remaining lease balance within two (2) business days of vehicle grounding on hyundaidealerdirect.com that you agree to pay on the customer's behalf. Delayed payments may result in inaccurate invoice processing and may lead to customer dissatisfaction.
