The Legal Aid Foundation of Tallahassee Celebrates a Diverse Group of Leaders



The Legal Aid Foundation of Tallahassee is thrilled to announce **Thunderdome Tallahassee Class 3**, made up of a diverse and accomplished group of leaders in the local legal community. Thunderdome Tallahassee is an innovative, hands-on leadership and pro bono family law training program which equips both fresh and seasoned attorneys with the tools necessary to effectively handle pro bono family law cases.

The program is a novel means of providing **equal access to justice**, a critical human services need in our community. It is estimated that thousands of low-income residents in Leon County lack legal representation, despite a dire need. Legal representation in a family law context often equates to very basic needs including safety, stability and health for families and children. One class at a time, Thunderdome Tallahassee aims to greatly enhance the pool of competent service-oriented attorneys who can give their time and talent to help families in need.
