Contemporary Management of Short Bowel Syndrome

PROGRAM DESCRIPTION

This collaboration-focused session will provide a greater understanding of the complex management of SBS-IF, which has shifted from maximizing remnant intestinal absorptive capacity to enhancing its structural and functional integrity. Increased understanding of this new treatment paradigm, as well as the place of the newest therapeutic agents in the current armamentarium, will lead to an increased ability to deliver state-of-the art care for SBS-IF patients who are dependent on parenteral nutrition (PN).

Contemporary Management of Short Bowel Syndrome will review the clinical perspectives and respective roles of the care team, along with tactics for collaboration. The activity will also explore the incorporation of trophic agents to increase the chances of weaning patients from PN and improving their overall quality of life.

TARGET AUDIENCE

This CME-certified activity is intended to increase the knowledge and competence of physicians, dietitians, pharmacists, nurses, NPs, PAs, patient educators, as well as other members of the team who care for PN/IV-dependent patients with SBS-IF.

- Collect a thorough patient history to define bowel anatomy and identify any steps already taken toward the management of SBS-IF
