Application for EMERGENCY Relief

Louisiana REALTORS® has established an **EMERGENCY** relief fund for persons who have suffered losses due to the flooding disaster in August 2016. Relief assistance is restricted to parishes for which the governor has declared a state of disaster. To apply for **EMERGENCY** assistance, complete this form in full and attach any required documentation. Only one applicant per property address shall be eligible for funding. All information provided on the form will remain confidential. All funding requests are contingent upon the availability of funds. Assistance will be rewarded to those who meet the established criteria. The amount rewarded shall be up to \$500.

Eligibility Checklist

- Are you a full-time resident of Louisiana and a U.S. citizen or legally admitted for residence in the U.S?
- Have you been displaced from your primary residence or has your home incurred severe damage due to flooding?
- Is your primary residence in a parish for which the governor has declared a state of disaster?

If you meet all of the above-listed criteria, you may be eligible for financial assistance from the relief fund.
