KEYNOTE SPEAKER:

WILLIAM L. E. DUSSAULT, Attorney at Law, received his Juris Doctorate from the University of Washington School of Law in 1972. He is a member of the American Bar Association, Washington State Bar Association, Colorado State Bar Association, and Seattle-King County Bar Association and has been admitted to practice in the State of Washington (1972), United States Federal District Court (1973), United States Supreme Court (1982) and the State of Colorado (2006). He maintains a private practice in Seattle, Washington with an emphasis on the rights of persons with disabilities.



Mr. Dussault's primary area of interest is special education having drafted Washington State's mandatory special education law "Education For All" in 1970 and represented parents and children in hundreds of special education disputes. Mr. Dussault was the originating author of special needs trusts for use in personal injury settlements (known as "Dussault Trusts"), and the originating author of 42 U.S.C. §1396p(d)(4)(A), the federal legislation authorizing use of special needs settlement/judgment trusts in conjunction with continuation or establishment of eligibility for certain federal benefit programs. He is actively involved with numerous state and national groups concerned with legal issues impacting persons with disabilities, including the ARC, BIA, Autism Society, Epilepsy Foundation, ACMRDD and UCP. He has served as counsel to The Association for the Severely Handicapped (TASH), as Vice-Chair of the American Bar Association Family Law Committee on Mental Disability, counsel to the Washington Association for Persons with Disabilities, and is a past-President of the Washington Chapter of the National Association of Elder Law Attorneys (NAELA). Mr. Dussault was an adjunct professor at the University of Washington School of Law and the University of Washington School of Nursing on Nursing, Law and Ethics. He has served as a member of Washington State Bar Association Rules of Professional Conduct Committee, a contributing editor to the National Structured Settlement Trade Association "White Paper" quarterly, was a Member of the Board of Directors and Vice President for Finance for the Brain Injury Association of America from 1996 through 2001. He was a member of the faculty of Emmanuel College, Cambridge University, England, International Institute on Head Injury and the Law. He has been selected as one of Washington's Super Lawyers by Washington Law & Politics annually from 1999 through 2009, by Seattle Magazine as one of Seattle's top financial managers in 2010 and 2011, by Washington Law & Politics and Butch Blum as one of the four best lawyers in Washington State in 2003, and was awarded the Washington State Bar Association's highest honor, the Award of Merit, in 2012.
