Street Faire Rules and Additional Information

In case of inclement weather, the Chamber is unable to have rain dates or give refunds or credits. The Faire will still go on.

Previous vendors must apply by the previous vendor cut-off to retain their same space.

All vendors selling are required to hold a valid California Sellers Permit. There is no charge for the permit and it can be obtained by calling 800-400-7115 or online at www.boe.ca.gov. You must post your Resale permit in your booth the day of the event.

Spaces must be paid for when a completed Street Faire application is submitted to the Lodi Chamber of Commerce office, 35 S. School Street Lodi, CA 95240.

Vendors must go to their assigned check in location after 4:00 am on the day of the event. Vendors will not drive into barricaded area until they have checked in at their assigned location and have received authorization to enter.

All space numbers are on the curbs of the streets. The number is approximately the middle of your space. Spaces are 13x13 unless you were notified that you are in a 10x10 space.

Vendors may drive up to their space to unload but all vehicles must be parked outside of the barricaded areas by 7:30am. Vendors should also have their space set-up by this time. The event runs from 8am to 4pm. Vendors may not tear down their booth before 4pm. All vendors must be packed up by 6pm.

No generators are permitted and no electricity is available.

Vendors are not allowed to distribute promotional flyers, etc. outside of their space.

No beverage sales are allowed.

Only pre-approved food items are allowed to be sold or given away from vendor spaces. There is an additional charge of \$35 for pre-packaged food vending. A completed temporary food vendor's application must also be submitted with your application.

No free face painting. No silly string is to be used or sold at this event

The Chamber only provides the vendor space. Vendors must supply their own awnings, tables, display boards, etc. and must stay within their space.

We do not promise exclusivity. We reserve the right to refuse service to anyone.

Should you have any issues during the event, please contact a golf cart driver or come to the back of the Chamber office located at 35 S. School St.
