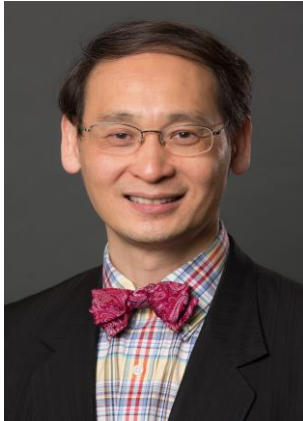


## Bio-Sketch of Calvin Q. Pan, MD, MACP, FACG, FAASLD The Recipient of the James D. Bruce Memorial Award



Calvin Pan, MD is Clinical Professor of Medicine at the Division of Gastroenterology and Hepatology, Department of Medicine in NYU Langone Medical Center, NYU School of Medicine in New York.

Prior to joining the faculty at NYU School of Medicine where he attained the rank of Full Professor of Medicine in 2012, Dr. Pan has held academic positions of Assistant Professor and Associate Professor at the Mount Sinai School of Medicine in New York. Dr. Pan currently chairs the online learning committee in the American Association for the Study of Liver Diseases (AASLD). He also is a member of numerous committees in other academic organizations, such as the educational committee of the American College of Physicians (NY), international relationship committee of the American College of Gastroenterology, committee of the Coalition to Eradicate Viral Hepatitis in Asia Pacific, and committee of the National Task Force on Hepatitis B in the US. He served as a Vice President of the Association of Chinese American Physicians (ACAP) from 2010 to 2012.

Dr. Pan maintains a large GI private practice with a focus on liver diseases in Flushing, New York. He is also a clinical researcher with interest on the prevention and treatment of viral hepatitis. He has been a leading principle investigator for a number of multi-center trials on antiviral therapy for Hepatitis B or C and trials on preventing mother to child transmission of hepatitis B. As a major contributor, he has presented original articles in the New England Journal of Medicine, Lancet, Hepatology, and other high impact journals. He serves as a primary writer for the expert consensus guidelines on chronic hepatitis B in the US and the international consensus guidelines on vertical transmission of hepatitis B. Dr. Pan has authored and co-authored 115 scientific publications in peer-review journals including original articles, reviews, and abstracts. He is an academic editor for the Journal of Clinical and Translational Hepatology and was an associate editor for the North American Journal of Medicine Science. In addition, he chairs the review group on hepatitis B for abstracts submitted to the annual scientific meetings of the AASLD and Digestive Disease Week. Dr. Pan is a Master of the American College of Physicians (ACP), Fellow of AASLD, and Fellow of American College of Gastroenterology. As an expert and key opinion leader in his specialty, he serves as a keynote speaker at numerous international scientific congresses, expert consultant meetings of World Health Organization (WHO), and Web-CME events.

Dr. Pan has received numerous awards for his contributions to medical sciences and patient care, including the Mastership Award from the American College of Physicians, Outstanding Contribution Award from the Chinese Society of Infectious Diseases in China, and Certificate of Service Appreciation from the American Cancer Society. Recognized by colleagues on his research works in preventing hepatitis B transmission by establishing the model of risk assessment and antiviral therapy during pregnancy, the Board of Regents of the American College Physicians has voted to select him as the 2017-2018 recipient of the James D. Bruce Memorial Award for Distinguished Contributions in Preventive Medicine. The award will be presented on Thursday, April 19, 2018 at the Convocation Ceremony during ACP's Meeting 2018 in New Orleans, Louisiana.
