Will be graded by the coalition based on answers and the 4 awardees will be notified on January 15th, 2019. You must be working (paid or volunteer) in San Joaquin County with pregnant and/or breastfeeding moms.

### What is covered/not covered?

#### Q: What will the scholarship cover?

A: The scholarship will ONLY cover the cost of the course

#### Q: What is NOT covered?

A: The coalition will not cover any other expenses including, but not limited to the cost of books, resources, or materials needed to complete the course, cost of transportation to the course location in Stockton, compensation for time away from work/school to complete the course.

#### Q: What else do I need to know?

A: This is a college level course, homework is assigned at a college level. The homework is graded and must be completed to complete the course and receive your certificate. If you do not complete the course, the coalition will revoke the scholarship and you will be responsible for the cost of the course. Your supervisor must sign the bottom of your application to acknowledge you will be given the time (whether paid or not) to take the course.
