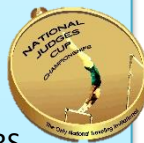

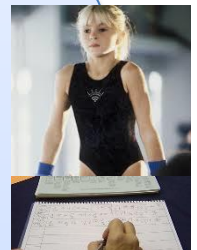

National Judges Cup Team Challenge Qualification for VA Team:

1. Competitors must meet eligibility criteria: Participants must have competed as a L7 in the VA 2016 Level 7 State Meet; OR are registered to compete Level 7 during the 2016-2017 Season.
2. Must register & compete in the VA Team Challenge Qualifier 11/5/16.
3. Must qualify by placing in the TOP 6 All Arouns overall. A 7th Place AA will be named 1st Alternate for replacement purposes.
4. Must commit to the competition in VA Beach before the VA Team is named at awards.
5. As a VA Team member the following will be sponsored by VA NAWGJ:
 - paid entry fee to National Judges Cup
 - Sized & Receive a VA Team Leotard, Warm Up Jacket & Leggings.
 - Must have one of their club's coaches accompany them to the meet & coach them during the meet.
 - Must Provide their own transportation, meals & lodging.
