

REQUEST FOR PROPOSALS STRATEGIC PLAN FACILITATOR RELEASED: AUGUST 8, 2017

PURPOSE OF THIS REQUEST

The Kamloops Chamber of Commerce is a membership-based, not-for-profit organization, governed by a board of directors. Every three years, the Chamber develops a new strategic plan and the Chamber's next plan will span from 2018 through 2020. The purpose of this RFP is to secure a facilitator for the Chamber's strategic planning session in October.

ELIGIBLE BIDDERS

- Certification in strategic planning through acquired education or a combination of education and experience that demonstrates expertise in the area proposed.
- A minimum of 3 years practical strategic planning experience required.
- Must be willing to develop a strategic plan document following the Chamber's current format. A copy
 of the current plan is available online.
- o Preference will be given to Chamber of Commerce members in good standing.

PLAN DETAILS

The strategic plan facilitator should meet the following requirements:

- Survey current directors and staff prior to session.
- Survey key community stakeholders prior to session.
- o Compile data from above surveys and from recent focus groups and member survey.
- o Read and be able to relate philosophies regarding "Horizon Initiative: Chambers 2025" document.
- o Facilitate a one-day session in October.
- Deliver session notes to Executive Director for easy transfer to strategic plan template.

PROPOSAL GUIDELINES

All submissions must contain the following information on a maximum of two pages:

- o Name and credentials/experience of facilitator(s).
- Outline of process including surveying, structure of the session and ability to work within the Chamber's template and verbiage.
- Mechanics including A/V requirements and preferred type of seating (classroom, boardroom, open square, square, etc.).
- Outline of fee structure.
- o Testimonial(s) or referrals from two (2) past clients and/or video of past sessions.
