United States population is 51% women

New Hampshire population is 51% women

Current information for the Class of 2020 at UNH School of Law is 54% women

Approximately 35% of the active members in the NH Bar Association are women

Approximately 33% of the NH Judiciary are women

According to NAWL's 2015 survey, only 18% of women occupy equity partner positions
