

More Election Information

Access your Virginia voter record to update your registration, apply to vote absentee, and view your polling place, election district, absentee ballot status, voting history and what's on your ballot for the upcoming election at <http://elections.virginia.gov/citizen-portal>, the **Virginia Department of Elections Citizen Portal**.

If you are already registered at your current address, you do not need to register again. **All voters must provide an acceptable form of photo identification (photo ID) at the polls.** Acceptable forms of identification are listed on the Virginia Department of Elections Citizen Portal above.

To find the location of your polling place, go to the Virginia Department of Elections Citizen Portal above.

Absentee Voting

There are **19 valid reasons to vote absentee in Virginia**, including working and commuting to and from home for 11 or more hours between 6 a.m. and 7 p.m. on Election Day. Check to see if you are eligible at the Virginia Department of Elections Citizen Portal.

Proposed Amendment to Article I, Bill of Rights, Section 11-A, Right to Work

Question: Should Article I of the Constitution of Virginia be amended to prohibit any agreement or combination between an employer and a labor union or labor organization whereby (i) nonmembers of the union or organization are denied the right to work for the employer, (ii) membership to the union or organization is made a condition of employment or continuation of employment by such employer, or (iii) the union or organization acquires an employment monopoly in any such enterprise?

NO I recommend that you vote "NO."

Explanation: Since 1947 the provisions of this amendment have been the law and the declared public policy of the Commonwealth (§ 40.1-59 of the Code of Virginia). The proposed amendment places the provisions of Virginia's right to work law into the Constitution of Virginia making any changes to labor-management laws more difficult. I voted against this amendment in the legislature because it is intended to limit laborers rights to unionize.

Proposed Amendment to Article X, Taxation and Finance, Section 6-B Property tax exemptions for spouses of certain emergency services providers.

Question: Shall the Constitution of Virginia be amended to allow the General Assembly to provide to localities an option to exempt from taxation the real property of the surviving spouse of any law-enforcement officer, firefighter, search and rescue personnel, or emergency medical services personnel who was killed in the line of duty, where the surviving spouse occupies the real property as his or her principal place of residence and has not remarried?

YES I recommend that you vote "YES."

Explanation: The proposed constitutional amendment authorizes the General Assembly to enact a law that would allow localities to exempt from property taxation the property of surviving spouses of the listed emergency services providers whose property is already exempt. It applies to the surviving spouse's principal place of residence, and the exemption ceases if the surviving spouse remarries.

Meals Tax Referendum

Question: For the purpose of reducing dependence on real estate taxes, shall the Board of Supervisors of Fairfax County, Virginia, be authorized to levy a tax on prepared food and beverages, otherwise known as a meals tax, as allowed by Virginia Code § 58.1-3833, at a rate not to exceed four percent (4%) of the amount charged for prepared food and beverages (which, based upon state law, is applicable only to sales outside of the town of Clifton, and towns of Herndon and Vienna that have already implemented a meals tax)? The revenues generated shall be dedicated to the following purposes: 1. 70 percent of the net revenues to Fairfax County Public Schools. 2. 30 percent of the net revenues to County services, capital improvements and property tax relief.

YES I recommend that you vote "YES."

Explanation: A meals tax would allow the County to diversify its revenue and reduce dependence on real estate taxes that now provide nearly 65 percent of its general fund revenue. Meals tax revenue would help the County meet its obligations for a growing school population and community demands for the very best schools. Cur

rently Arlington County, the cities of Alexandria, Falls Church, and Fairfax, and the towns of Herndon and Vienna have a meals tax.

Fairfax County Transportation, Parks and Human Services Bond Questions

There are three questions on the ballot related to Fairfax County being able to issue bonds for the purposes indicated:

YES	Transportation Bonds,	\$120,000,000
YES	Parks and Park Facilities Bonds,	\$107,000,000
YES	Human Services/Community Development Bonds,	\$ 85,000,000

I recommend that you vote "YES" on all three bond questions as they provide necessary resources in the most economical way to meet the needs of our growing County.
