The Emergency Medical Technician (EMT) or Paramedic (CEP) position is a non-sworn/non-fire suppression position. All Emergency Medical Care Technician (EMCT) personnel are required to successfully complete an orientation/training program that will consist of, but is not limited to, EMS operations, EMS transportation, EMS skills, physical fitness, and other related subjects.

Minimum Qualifications: To perform either job successfully, an individual must be able to satisfactorily perform each essential duty as listed in the job description including:

- High school diploma or general education degree
- 21 years of age at time of application
- Possess and maintain a valid State of Arizona operator's license with a good driving history
- State of Arizona EMT or Paramedic Certification

Selection Process: Applicants whose experience and skills most closely meet the needs of this position may be invited to participate in a testing process. Selection criteria may include any or all of the following: review of submitted application; written examination and/or assessment center; physical ability test; oral board; background/driver's license verification and check; and conditional offer of employment psychological testing, physical exam and/or drug screen.

Preference points will be given to veterans.
