History of the Tiadaghton Elm

West of the Lycoming Creek, the Pine Creek inhabitants, having no legal body for protection or legislation, formed their own law-making group called the Fair Play System. The settlers on the disputed territory were

intensely patriotic; being outside the jurisdiction of law, except that of their own making, they felt freer to act than those who were under the protection of the provincial government. On the west bank of the Pine Creek near Jersey Shore stood the famous Tiadaghton Elm under which on July 4, 1776, the Fair Play Men drew up a resolution declaring freedom from Great Britain.

Accordingly, they met on July 4, 1776, under the spreading branches of the enormous elm tree on the west bank of Pine Creek in what is now known as Clinton County, and solemnly declared themselves free and independent and forever absolved from all allegiances to the British crown. They did not realize that at this precise time, the Continental Congress in Philadelphia was doing the same thing. The independent action under the giant Elm, without any knowledge of what was happening that same day in Philadelphia, is testimony to how remote and self sufficient these

people were both mentally and physically. They had created their own Declaration of Independence and their own country, free of England. Even today, many parcels of land are held with deeds bearing the name William Penn, the first governor.

"Under this elm, on July 4, 1776, resolves the declaring independence were drawn prior to news of action by Congress at Philadelphia. This was an expression of the spirit common to the frontier and led by the famous Fair Play Men."
