Presenters Brief Bio

Dr. Kirk Moberg MD, PhD, FASAM has practiced in the field of addiction medicine for the past 20 years. During that time he has served as medical director of three addiction treatment centers serving currently as medical director of the Illinois Institute for Addiction Recovery in Peoria, Illinois. Dr. Moberg has extensive experience implementing medication assisted treatment programs including buprenorphine programs.

As a triple alumnus of the University of Illinois, Dr. Moberg holds a M.S. in Health Policy and Administration, a Ph.D. in Biology as well as a medical degree. Certified by the American Board of Internal Medicine, the Certifying Commission on Medical Management and the American Board of Addiction Medicine he is a fellow of the American College of Physicians and the American College of Physician Executives.

Dr. T. Celeste Napier, Ph.D. - Rush University Medical Center, is Professor of Pharmacology and Director, Center for Compulsive Behavior and Addiction The research interests of Dr. Napier's laboratory are focused on changes in the adult mammalian brain that alter motivative behaviors, including those associated with drug addiction and its co-morbidity with other mental and neurological diseases. Behavior, pharmacological, electrophysiological and biochemical approaches are used in rodent models of the human brain disease to ascertain neuronal substrates that are altered during the course of these disorders. The work is directed towards developing novel therapeutic targets that can nullify the disease-related brain alterations.

Christine Reilly, M.A., Senior Research Director for the National Center for Responsible Gaming. In this capacity, Reilly administers the NCRG's research grant programs and coordinates educational activities such as the annual NCRG Conference on Gambling and Addiction and the EMERGE Training program (Executive, Management, and Employee Responsible Gaming Education). Previously, Reilly served as the executive director of the Institute for Research on Pathological Gambling and Related Disorders, from 2000 to 2009. She also was the first executive director of the National Center for Responsible Gaming (NCRG), from 1997 to 2000. The National Center for Responsible Gaming (NCRG) is the only national organization exclusively devoted to funding research that helps increase understanding of pathological and youth gambling and find effective methods of treatment for the disorder.

Gene O'Shea is a former journalist who joined the Illinois Gaming Board in 2000 after fourteen years with the Daily Southtown cover criminal courts and law enforcement in Chicago. Soon after joining the IGB's staff he was asked to begin developing a Self-Exclusion Program for Problem Gamblers which was implemented in 2002 via the Rule Making process. Mr. O'Shea is the Director of the Illinois Gaming Board's Self-Exclusion Program for Problem Gamblers.
