## Terms of Contract

1. This contract is for the rental of a locker in the Ann Arbor Figure Skating Club (AAFSC) Locker Room at the Ann Arbor Ice Cube. To be eligible to rent a locker a Skater must be an active member of the AAFSC in good standing.
2. Lockers are provided by the AAFSC for the convenience of its skaters and the AAFSC is not liable for contents placed within the locker.
3. The rental price is \$30 per year with payment due upon submission of signed contract.
4. The rental term begins July 1<sup>st</sup> 2018 and all contracts end June 30<sup>th</sup> 2019. Locker rental charges cannot be prorated for any reason.
5. Skaters who are currently using lockers for the 2017-2018 season have until August 1<sup>st</sup> to renew their locker contracts. If the skater fails to pay the fee by August 1<sup>st</sup>, the AAFSC will remove the lock and the locker contents so that the locker can be rented to another skater by August 15<sup>th</sup>. The contents of any locker emptied by the AAFSC will be held in the club office for 30 days. After 30 days the property will be disposed of at the discretion of the AAFSC. The AAFSC will not be liable for any belongings in an abandoned locker.
6. Skaters may opt to share a locker. The AAFSC recommends that no more than 2 skaters share a locker. If a locker is being shared, only the person on this contract will be notified in the event of an issue with the locker. Both skaters should sign the contract for the locker rental.
7. The AAFSC does not provide locks, therefore skaters must supply their own combination locks and all locker combinations must be provided to the AAFSC. The AAFSC must be able to access lockers in the event of necessary maintenance or for any other urgent issue. In the case of scheduled maintenance the skater will be given notice via email, phone call or in person that the

locker will be opened. In the event of an urgent issue, skaters will be notified as to the reason and date that the locker was opened, but notice is not required.

8. If the lock combination changes the skater must update the office with the new combination. If the office is not informed and the result is that the AAFSC has to remove the lock for maintenance or an urgent issue, the AAFSC is not responsible for replacing the lock nor is it responsible for locker contents in any duration that the locker is without a lock. The skater will have to purchase a new lock and provide that new combination to the office.
