Mia Ray Langheim, School Intelligence Officer, Illinois State Police, Statewide Terrorism & Intelligence Center

This presentation will reflect over school and campus shootings/attacks from the past five years and briefly review after-action findings from some of the shootings and other safety disruptions in schools. Craig Scott, Rachel's Challenge

Craig was at the scene of the worst high school shooting in U.S. history at Columbine High School. Craig was in the school library where 10 classmates were killed and over 20 wounded. After witnessing two of his friends murdered next to him, Craig led a group of students out of the school. "The inspiring story of Rachel Scott whose example of kindness and acceptance was brought to light when she became the first victim in the Columbine High School tragedy. Conveyed through stories from Rachel's life and writings, this keynote address shows the profound positive impact we can have on those around us. The presentation demonstrates to the listener the power of deliberately reaching out in word and action to others to start what Rachel called "a chain of reaction of kindness and compassion." It encourages participants to examine their own lives in the light of five challenges.

"The Data Was There - They Said. How Open Source Social Media Data Can Be Utilized for School Safety"

The vast majority of recent school violence attacks have had precursors leaked online in the form of social media posts. Knowing where, how and when to look for this critical information is the current challenge this nation faces. The real time gathering and assessment of publicly available social media plays an imperative role in mitigating and preventing school violence. The latest trends in social media use and misuse, the current landscape of digital behavioral violence threat/risk assessment, and relevant open source information gathering techniques will be covered.

This presentation will review current trends in cybercrimes involving children, best practices when investigating cybercrimes that are initiated in a school environment, and how to properly document cyber based evidence.
