## SPECIAL PANEL DISCUSSION WITH GOGO, INC. BOARD OF DIRECTORS

### **RON LEMAY**

Ron LeMay is chairman of the Board of Directors of Gogo, Inc. He serves as managing director for Open Air Equity Partners. Its portfolio companies include Gogo Inflight, Main Street Data, and



Hyla mobile. LeMay has founded or cofounded eight companies in the last 10 years. Mr. LeMay was formerly president/COO of Sprint Corporation for almost 20 years and CEO of Sprint PCS. Mr. LeMay is a lawyer who practiced for 10 years in private practice and as corporate counsel.

#### **OAKLEIGH THORNE**

Oakleigh Thorne founded, and serves as CEO of, Thorndale Farm, Inc., which oversees the Thorne family investment portfolio, including investments in Gogo, Inc. and Helix Education Inc.,

as well as other investments. He is a member of the Board of Directors of Gogo, Inc.

Prior to founding Thorndale Farm in 1996, he served as CEO of Commerce Clearing House, Inc. Thorne led the sale of CCH for \$1.9 billion to Wolters Kluwer in 1996. Thorne also served as Chairman and CEO of eCollege.com (2000–07).

A member of the Board of Directors of Gogo, Inc., Michele Coleman Mayes is vice president, general counsel, and secretary for the New York Public Library. Previously, she served
