In late 2015, Bob donated \$1 million to our Endowment to support our Safety Around Water initiative. The Safety Around Water initiative will provide free water safety instruction to third grade students from

throughout the Fox Valley. We are proud to carry Bob's legacy forward to generations of children.

Those few moments make a lasting impact on a child's camp experience. Camp goes from feeling foreign to feeling like "home," a place where people care about their experience and challenge them to be their best.



Youth Sports

With a focus on having fun, our youth sports programs promote healthy youth, family involvement, skill development and healthy competition to help children become better players and better people by focusing on our core values of Caring, Honesty, Respect and Responsibility.

Safety Around Water

At the Y, we are building stronger swimmers and confident kids through our Safety Around Water program, which teaches third-graders in our community how to be safe in and around the water. The YMCA's Safety Around Water Program is proven to reduce the risk of drowning and gives children confidence in and around water.

Aquatics

Learning to swim at the Y is more than just stroke development. Through our child-centered approach, kids learn through play, hands-on exercises and creative repetition. Small group lessons take a progressive approach, which allows each child to advance at their own pace. We help families discover the benefits of swimming while having fun learning.

• **Participants served:** 12,539

When campers enter their teen years, many feel ready to take their first steps into adulthood and transitioning from camper to counselor-in-training is a welcome challenge. Becoming a counselor involves hard work, taking healthy risks and will push them out of their comfort zone more than ever; but these challenges will teach them that they are developing into their best selves. Younger campers look to their counselors as role models and friends. This is the biggest reward of all!

The training is challenging but rewarding and the counselors have gained confidence in their ability to lead songs and games, pitch a tent, lead a canoe trip and conquer the high ropes course. They know this is the time to pass their knowledge and love of camp onto the next generation.

Camp is a place to gain the confidence and leadership skills that are needed in the “real world.” The full camp experience provides our youth the training they need to live and thrive on their own. Campers and counselors know that camp doesn’t only last one week, camp lasts a lifetime.

Youth in Government

The Youth in Government (YIG) program takes a hands-on approach involving students in the legislative, executive and judicial branches of government. This includes a Press Corps, which gives students experience in sharing political news in a variety of media platforms. YIG encourages life-long responsible citizenship through the study of public issues, debate on public policy, writing legislation, debating court cases, reporting on political news and a weekend Model Government experience in the State Capitol.

LIVESTRONG®

LIVESTRONG at the YMCA is a 12-week small group program designed to help adult cancer survivors achieve their holistic health goals. Participants work with Y staff, trained in supportive cancer care, to achieve their goals such as building muscle mass and strength, increasing flexibility and endurance, and improving confidence and self-esteem safely. By focusing on the whole person and not the disease, LIVESTRONG at the YMCA is helping people move beyond cancer in spirit, mind and body.

“My advice to anyone who finds themselves in a similar situation is to start by making one small change at a time.”

“I was a collegiate level football player and wrestling coach for many years, maintaining a certain level of fitness, but also dealing with various injuries. In 2011, I stopped working out due to an injury and over the next 18 months gained 165 pounds.

I could no longer walk from a first row parking spot into my office without stopping to rest.

I decided a change needed to happen so I went to the Y and became a member. My first day I was only able to do 5 minutes on a bike, but over the course of a month I worked up to 30 minutes. I decided to join a cycling class and went from one class a week to doing a 45-minute Tabata class every day. I began to lose weight and decided to try some of the more difficult 60-minute classes like Boot Camp. The people around me kept telling me what an inspiration I was and asked if I would consider becoming an instructor at the Y. Being a coach for many years, I thought it was something I would like so I began teaching a Retro Cardio Class at the Y.

The classes are really what keeps me motivated and the instructors are amazing. They encourage me on my milestones, and encourage others to make changes.

I have lost over 285 pounds in the past 4 years.

My advice to anyone who finds themselves in a similar situation is to start by making one small change at a time. My first change was to rejoin the Y and to go at it slow. It's not going to happen overnight but by making small changes I have been able to go from 5 minutes on a bike to 60-minute high intensity classes 6 or 7 days a week.”

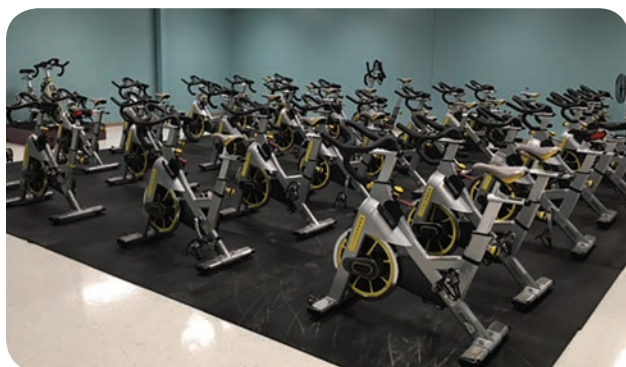

The YMCA of the Fox Cities embarked on its “Growing Stronger Together” Capital Campaign raising over \$8.7 million to improve and expand four existing YMCA of the Fox Cities’ facilities that are aging and experiencing tremendous growth.

The community response was overwhelmingly supportive and all goals were reached. 2016 was a year of transformations, renovations and expansions that will help the Y continue to serve the ever-growing and changing population, and safely and efficiently deliver high-quality programs to all who wish to participate.



HIGHLIGHTS FOR EACH OF THE PROJECTS INCLUDED:

- **Appleton YMCA** – Enhanced security of child care area, enhanced Welcome Center and Member Services areas, lower lobby service area renovations and enhanced building accessibility.
- **Fox West YMCA** – New first-floor Wellness Center, gymnasium addition, second-floor multi-purpose space, enhanced Member Service area and new playground.
- **Heart of the Valley YMCA** – Family locker room expansions, Wellness Center and free weight expansion, aerobic and cycling studio additions and additional office space.
- **Neenah-Menasha YMCA** – Complete renovation of Adventure Alley indoor play area and upgrades to the men/boys, family and special needs locker rooms.

In addition to these renovations, each Y location received wellness equipment upgrades. YMCA Camp Nan A Bo Sho received a grant for renovations to the Orbison Lodge and Waterfront bathrooms and all outer camper cabins which included new flooring, lighting, ventilation and enlarged square footage.

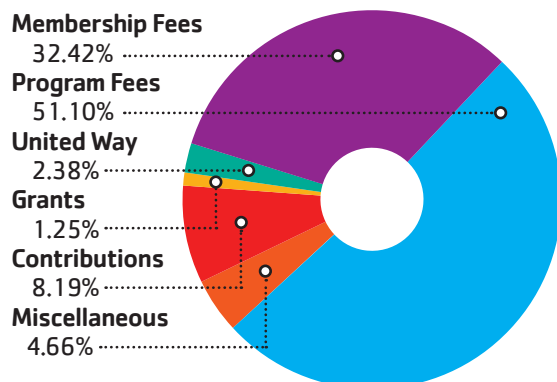

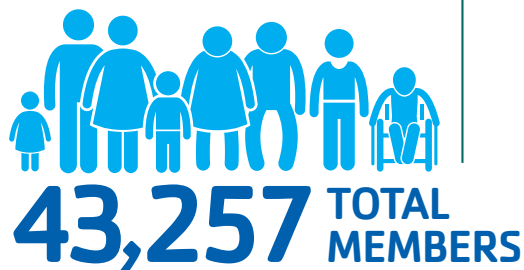
