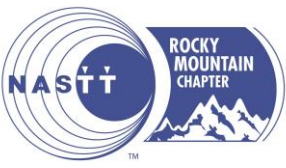

### NASTT'S ROCKY MOUNTAIN CHAPTER MUNICIPAL & PUBLIC UTILITY SCHOLARSHIP PROGRAM POLICY

#### **Eligibility**

Scholarship applicants must be a full-time employee of one of the following organizational types located within Colorado, Montana, Utah and Wyoming:

- "Municipal" - Defined as an incorporated or chartered governmental unit or local council authority providing infrastructure services, either urban or rural, to cities, towns, villages, townships, boroughs, counties, hamlets, regions, or districts.
- "Public Utility" - Defined as a business that furnishes an everyday necessity to the public at large providing water, electricity, natural gas, telephone service and other essentials. Utilities may be publicly or privately owned.
- "Other" - Defined as Federal government, including Military; State government; Provincial government; and Institutional organizations such universities, colleges, medical campus, or any special purpose facility maintaining infrastructure.

Individuals employed by governmental or public corporations via short term contractual arrangements are not eligible for this program. Should a scholarship recipient's employment end or be terminated prior to commencement of Trenchless Elevated 2018, then the scholarship shall be rescinded by NASTT's Rocky Mountain Chapter with no transfer to an alternate attendee. NASTT's Rocky Mountain Chapter reserves the right to define and determine eligibility of this program as well as cancel, modify or terminate any and all enrollments.

Care and confidentiality shall be exercised by NASTT's Rocky Mountain Chapter to guarantee privacy protection for any and all personal information submitted. Incomplete or indecipherable applications shall be rejected. All information contained in the scholarship application must be complete, true and verifiable.

#### **Terms & Conditions for Acceptance**

Notices of award shall be by email. If a scholarship is awarded, applicants must respond and confirm their acceptance by the deadline date as set by NASTT's Rocky Mountain Chapter in the email notice. If the applicant does not respond to the scholarship offer by the date outlined in the email offer, the scholarship shall be rescinded without appeal.

Scholarships are non-transferable and have no redeemable cash value.

NASTT's Rocky Mountain Chapter does not accept responsibility for the scholarship recipient(s) while onsite for Trenchless Elevated 2018 or during travel periods to and from the event. The scholarship recipient(s) and their employer shall indemnify and hold harmless NASTT's Rocky Mountain Chapter, and their affiliate agents, from and against any claim, demand, loss, expense, damage and any other liability or prejudice arising during or in connection with participation in this program.

Professional and ethical behavior is expected and required at all times while attending Trenchless Elevated 2018 and NASTT's Rocky Mountain Chapter reserves the right to rescind a scholarship at any time without appeal.
