EXHIBITION PROSPECTUS

- **Show Theme: Summer Soliloquy**
(Paintings should take into consideration the theme of this exhibition)
- **Number of Entries:** UWS members may submit two (2) entries.
 - ✓ Professional Artist Category
 - Those who have art degrees, teach art courses, are represented by galleries or who derive \$3,000 or more per year in income.
 - ✓ Amateur Artist Category
 - Non art degreed individuals who derive less than \$3,000 in sales from their art work and are not represented in galleries.
- **Entry Fee:**
\$20 first entry; \$15 for the second. (Note no refunds will be issued once an entry is made.) **Manual**
Entries will be allowed on June 28 but will be assessed an additional \$5.00 registration fee per entry.
 - ✓ All paintings must be for sale.
 - ✓ All paintings must hang for the duration of the show unless purchased and removed by the buyer.

- ✓ By entering this show, you grant permission for use of your artwork image for publicity purposes.

Paintings Pick Up: August 29 or August 30, 2017 at Fuhrimans Framing and Fine Art, 75 South Main, Logan, UT 94321 from 10:00 - 4:30 p.m.
- **General Requirements:**
 - ✓ All work must be original, conceived and created by you. Photographic references used, must be your own.
 - ✓ No work produced under instruction or in a workshop is permitted.
 - ✓ Copies of another's work or recognizable use of copyrighted intellectual property is not permitted.
 - ✓ Paintings must have been completed within the past two years and not previously exhibited in a juried or judged exhibit sponsored by the Utah Watercolor Society.
 - ✓ Paintings may not have been previously exhibited at Fuhrimans Framing and Fine Art.
 - ✓ Entry must be watermedia on natural or synthetic paper, paperboard, canvas or silk or other media that accepts watermedia. Water media includes watercolor, acrylic, guache, water-based inks etc.
 - ✓ Water-based oils are not permitted.
 - ✓ Collages are eligible for this exhibition.
 - ✓ Work that is mixed media must be at least 75% water-based media in conjunction with other media such as pastels, ink or other watermedia or collage materials.
- **Size Requirements:**
 - ✓ There is no minimum size for this exhibition with or without frame.
 - ✓ Maximum size of work may be no larger than 22 inches wide and 24 inches long including mat and frame if a frame is used.
- **Mats:** Mats may be of any color or are optional.
- **Frames and Glass:**
 - ✓ Gallery-wrap presentations are acceptable.
 - ✓ All paintings must be ready to hang with wire supports.
 - ✓ Eye hooks are not permitted.
 - ✓ Glass or plexiglass is acceptable when using frames, but not required for varnished pieces.
 - ✓ Stable backing material required for all works.
 - ✓ All entries must use the label provided in this prospectus and be completely filled out with the following information:
 - Title of Painting
 - Medium (watercolor, acrylic, etc.)
 - Image Size
 - Artist first and last name
 - Telephone Number
 - Email Address
 - Price of Painting
 - Artists Statement
- **Exhibition and Judging:**
 - ✓ UWS-CVC and Fuhrimans Framing and Fine Art reserves the right to refuse, upon arrival, any piece for unacceptable quality, improper framing or failure to comply with entry requirements.
 - ✓ A commission of 40 % will be deducted from all sales.
 - ✓ No changes in price are permitted after entry of your work.

- ✓ By entering into this Exhibition, the artist enters into a contract with the Exhibition location and the Cache Valley Chapter of the Utah Watercolor Society, which will be the acting agent for the sale of your artwork.
- ✓ Note: While care is taken in handling entries and artwork neither UWS-CVC nor the exhibition venue are responsible for damage or loss of entries for any cause.
- ✓ Artists who sell painting may be asked to complete a W9 form. The form can be downloaded from the resources page of the UWS website, utahwatercolor.org
- ✓ Although photographs / jpgs are not required as part of the submittal process, please ensure that you have taken a good quality photograph / jpg before your artwork is under glass as it will be required if you are an award winner for future promotion use by UWS/CVC.
