THE OEC'S ANNUAL MEETING WITH CCA

Thank you to everyone who came out to our Annual CCA Meeting with the Office of Early Childhood (OEC). It was very informative and it is always great when Valerie Bryan and her team come out to answer all of our questions and update us on what is happening in the OEC.

Here are a few things that were discussed:

1. The OEC is moving to a new building on February 6th. New address, phone # fax number are- 2450 Columbus Boulevard, Suite 302, Hartford, CT 06103. (860) 500-4450. Fax (860) 326-0552. Linda Goodman is the acting Commissioner.
2. Epi-Pens- cost of Epi-Pens increased drastically and parents were frantic. May use CVS generic epinephrine injector [AdrinaClick](#). Be sure to know how to administer this different application.
3. All programs receiving Care 4 Kids funds- New Federal regs will now require minimum standards for unlicensed programs. Announced inspections will be done by Day Care inspectors from OEC.
4. In 2016 #1 most common violations was NO violations! Congratulations to those camps! Other common violations: Health documents missing or incomplete, staff records missing or incomplete, food service documents missing, Fire Marshall inspection missing. We all need to be better with our paperwork. 22 unlicensed cases- most were horse camps. 21 incident follow-ups mostly regarding issues with am & pm care, on the bus and child-on-child incidents. **If cited and camp does not comply by the next day, it cannot stay open.**
5. Can camps use CampDoc? OK if we can show physicals- online, on computer or hard copy.
6. Gardening- OK for campers to eat as part of their program. Cannot sell. 1913 B42- "approved sources". Check with Tracy Weeks @ DPH or local health to define "approved sources". Should not buy from local grocery store for camp.
7. Inhalers- RN's or Director can call physician to confirm/ clarify that even though it's listed on the PE, it may not be needed at camp. RN's only can take an order over the phone.
8. If we have to call DCF, we do not have to call OEC, but it would be nice if we did. Only call OEC for an incident at camp, not something at home.
9. When in doubt about anything, call OEC!


