The 2017 Ken Gillaspie Legacy Fund Scholarship recipient will be invited to participate in the 3-day "Fundamentals of Financial Life Planning" training session held September 12-14, 2017 in Portland, Oregon. The scholarship will cover the tuition in full and up to \$1,000 in related transportation, lodging, and food expenses. *Please note the scholarship award does not include fees for licensing Money Quotient materials.*

#### **Selection Process**

**Applications must be received by Money Quotient by FRIDAY, JUNE 30, 2017.** Members of the Money Quotient Advisory Board will comprise the selection committee. They will review the applications and make the funding decisions based on application responses, plans for implementation, potential for impact, and so on. The selected recipient will be notified by Monday, July 31, 2017.
