Program Description:

Amidst the changing Marijuana regulations, many Physicians are left with a lack of knowledge on the impact of legalization on their patients. This workshop will give physicians a better understanding of reward circuitry and genetic variability. It will also educate them on ways to incorporate patient screening as well advise parents on the legalization of Marijuana.

Learning Objectives: *At the conclusion of this session, attendees should be able to:*

1. Demonstrate an increased understanding of genetic variants within reward circuitry.
2. Implement ways to obtain supplemental history for atypical responses to drugs/medications.
3. Apply knowledge of risk/benefits of marijuana legalization on youth.
