2016 THEATRE Concession Program Terms and Conditions

Semester 1: January 1, 2016 – June 30, 2016
Semester 2: July 1, 2016 – December 31, 2016

Distribution & Rebates & Dates:

- 4 items = 4%
- Only products purchased between January 1, 2016 and June 30, 2016 (Semester 1) and between July 1, 2016 – December 31, 2016 (Semester 2) are eligible.
- Items must be in full distribution by **3/31/16** and enrollment form received by **4/30/16** to qualify for the 1st Semester distribution rebate.
- If the 1st Semester deadline is missed a 2nd Semester rebate can be earned if 2nd Semester items are in full distribution by **9/30/16** and an enrollment form is received by **9/30/16**. Only purchases from 7/1/16 – 12/31/16 will be paid.
- Minimum rebate threshold: \$25.00 -- rebates will not be issued for under \$25.00.
- All rebates will be paid on Hershey's Schedule 4 pricing..

Product purchased from a participating Concession Distributor will be automatically reported on your behalf.

If product is purchased from a non-participating Concession Distributor, please complete and submit a Purchase Summary Form for the appropriate Semester:

- Show number of cases (or boxes for King Size) purchased.
- Include copies of invoices documenting sales reported on the Purchase Summary Form. Invoice(s) must show invoice #, delivery date and item quantity received. Forms with incomplete documentation will be returned.
- Received no later than 15 days after the close of Semester. So, for Semester 1, this is July 15, 2016 and for Semester 2 it is January 15, 2017.
- A notary public completed affidavit must be included with each Semester's submitted Purchase Summary Form.

Hershey reserves the right to reject a transaction or disqualify account from participation in the program for non-compliance with the terms and conditions of the program. Hershey reserves the right to recover amounts paid to account as a result of fraudulent or duplicate Purchase Summary Form or other sales submissions for rebate payment.
