| AB 340 Arambula (D) | Early and Periodic Screening, Diagnosis, and Treatment | Support |
| | Requires that screening services under a specified Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) Program include screening for trauma. Requires the adoption of tools and protocols for screening children for trauma. | |
| AB 395 Bocanegra (D) | Substance Abuse Treatment Providers | Support |
| | CBHDA-Sponsored Bill. Modifies the specific controlled substances authorized for use in narcotic replacement therapy to include medication-assisted treatment. Modifies the conditions for the State Department of Health Care Services to authorize an office-based narcotic treatment program in a remote site to authorize a physician to treat a number of patients specified under the US Drug Enforcement Administration registration and modify the types of authorized pharmacological treatments. | |
| AB 488 Kiley (R) | Mental Health Services Act | Watch |
| | Establishes the Mental Health Services Fund Transparency and Accountability Office within the Health and Human Services Agency. Transfers various functions of the Department of Health Care Services to the office. | |
| AB 501 Ridley-Thomas S (D) | Mental Health: Community Care Facilities | Support |
| | Amends the Community Care Facilities Act. Authorizes a short-term residential therapeutic program to be operated as a children's crisis residential center, and requires regulation of those programs. | |
| AB 675 Ridley-Thomas S (D) | Medi-Cal: In-Home Supportive Services: Funding | Support |
| | Appropriates \$650,000,000 from the General Fund to the department for the purpose of continuing to make IHSS available to Medi-Cal beneficiaries through Medi-Cal managed care health plans under the Coordinated Care Initiative. | |
| AB 715 Wood (D) | Opioid Pain Reliever Use and Abuse Workgroup Review | Support |
| | Establishes a workgroup to review existing prescription guidelines and develop a recommended statewide guideline addressing best practices for prescribing opioid pain relievers. | |
| AB 727 Nazarian (D) | Mental Health Services Act: Housing Assistance | Support |
| | Clarifies that counties may spend Mental Health Services Act moneys on housing assistance for people in the target population under the Act. | |
| AB 917 Arambula (D) | Student Health: Student Suicide Prevention Policies | Support |
| | Requires the Board of Governors of the California Community Colleges and the Trustees of the California State University, and encourage the Regents of the University of California to adopt, at a regularly scheduled meeting, a policy on student suicide prevention that specifically addresses the needs of high-risk student groups. | |
| AB 1095 Harper (R) | Alcoholism: Drug Abuse Recovery or Treatment Facilities | Oppose |
| | Requires that specified facilities be considered a residential use of property for the purposes of any law or zoning ordinance that relates to such use. Provides an exception for a combination of 2 or more facilities that provide treatment and recovery services for a certain number of persons or more. | |
| AB 1136 Eggman (D) | Health Facilities: Mental or Substance Use Treatment | Support |
| | Requires the State Department of Public Health to develop and submit a proposal to solicit a grant under the federal 21st Century Cures Act to develop a real-time, Internet-based database to collect, aggregate, and display information about beds in inpatient psychiatric facilities, crisis stabilization units, residential community mental health facilities, and residential substance use disorder treatment facilities. | |

| AB 1340 Maienschein (R) | Medical Education: Mental and Physical Health Care | Support |
| | Requires the Medical Board of California to consider including in its continuing education requirements a course in integrating mental and physical health care in primary care settings, especially as pertains to early identification of mental health issues in children and young adults and their appropriate care and treatment. | |
| AB 1560 Friedman (D) | Nurse Practitioners: Supervision | Support |
| | Deletes the cap on the number of nurse practitioners a physician and surgeon may supervise at one time for purposes of furnishing drugs or devices. | |
| SB 8 Beall (D) | Diversion: Mental Disorders | Support |
| | Authorizes a court to postpone prosecution of a misdemeanor or a felony punishable in a county jail, and place a defendant in a pretrial diversion program, if the court is satisfied the defendant suffers from a mental disorder and meets certain other requirements. Allows the defense to arrange for a program of mental health treatment utilizing existing inpatient or outpatient mental health resources. | |
| SB 142 Beall (D) | Criminal Offenders: Mental Health | Support |
| | Requires, upon the request of a defendant, a probation officer to include in a certain report whether the defendant is currently, or was at any prior time, eligible for public mental health services due to a serious mental illness or eligible for Social Security Disability Insurance due to a diagnosed mental illness. Establishes the State Community Mental Health Performance Incentives Fund to provide for mental health incarceration rate reduction incentive payments to counties. | |
| SB 191 Beall (D) | Pupil Health: Mental Health and Substance Use Disorder | Co-Sponsor |
| | Authorizes a county, or a qualified provider operating as part of the county mental health plan network, and a local educational agency to enter into a partnership to create a program that includes, among other things, targeted interventions for pupils with identified social-emotional, behavioral, and academic needs and an agreement to establish a Medi-Cal mental health and substance use disorder provider that is county operated or county contracted for the provision of mental health services. | |
| SB 192 Beall (D) | Mental Health Services Act Reversion Fund | Watch |
| | Requires MHSA funding to be directed only to counties, or counties acting jointly, that provide evidence-based intervention services and supports for prevention, early detection, and treatment of psychosis, mood disorders, or other mental health issues for youth. | |
| SB 222 Hernandez (D) | Inmates: Health Care Enrollment | Support |
| | Requires the suspension of Medi-Cal benefits to end on the date he or she is no longer an inmate of a public institution or is no longer otherwise eligible for benefits under the Medi-Cal program. Requires the State Department of Health Care Services, in consultation with specified stakeholders, to develop and implement a simplified annual renewal process for individuals in a suspended eligibility status. | |
| SB 237 Hertzberg (D) | Criminal Procedure: Arrest | Support |
| | Authorizes an arresting officer to release an arrested person from custody without taking him or her before a magistrate if the person is delivered to a specified facility for the purpose of mental health evaluation and treatment and no further criminal proceedings are desirable. | |
| SB 554 Stone (R) | Nurse Practitioners: Independent Practice | Support |
| | Authorizes a nurse practitioner who holds a certification from a national certifying body, recognized by the Board of Registered Nursing, to be certified by the board as an independent nurse practitioner to perform certain functions without the supervision of a physician and surgeon, if the independent nurse practitioner meets specified requirements and practices in medically underserved areas or with medically underserved populations. | |
