

## Membership Investment Breakdown

Membership rates have been evaluated by the Board of Directors for the upcoming year. It was determined that the dues schedule in place needed to be revised to create a more portioned disbursement of rates based on categories. The Chamber of Commerce gave careful thought and consideration as to the new rate schedule to make sure that it was fair and equitable to the businesses (both small and large) throughout our service area.

Membership dues upon receipt of invoice, with annual statements sent in October to coincide with the Chamber's fiscal year, which begins October 1<sup>st</sup>. **Businesses joining after Oct. 1<sup>st</sup> will receive a prorated rate based on the number of months membership is active during that year.** All dues are nonrefundable.

Additional \$5.00 per unit for 11-51 units.  
For 51 units and above additional \$1.50 per unit.
