

TABE WAIVER FORM

Students intending to apply for workforce development programs are typically required to complete the Test of Adult Basic Education (TABE). If any of the following criteria applies and proper documentation is provided, the TABE may be waived.

- 1) Students who have earned a college degree at the associate of applied science (A.A.S.) level or higher
- 2) Students who have successfully completed developmental education requirements (REA 0017, ENC 0025, MAT 0028) (Students will be exempt from placement testing and basic skills exit examination in the subject area(s) in which they had successfully completed developmental education requirements)
- 3) Students who have successfully completed a college-credit English (e.g., ENC 1101) or math (MAT 1033) course with a grade of "C" or higher (Students will be exempt from placement testing and basic skills exit examination only in the subject area(s) in which they had successfully completed a college-credit course.)
- 4) Students who have passed a state or national industry certification or licensure examination identified in State Board of Education rules and aligned to the career education program in which the student is enrolled
- 5) Adult students enrolled in an apprenticeship program that is registered with the Department of Education
- 6) Test scores as indicated in the table below. All scores must be less than two years old in order to be used to waive TABE testing requirements.
