Employer Eligibility

- Licensed to operate in Ontario & provide employment in Ontario.
- Maintain appropriate WSIB or alternate workplace coverage & have third-party liability as advised by its insurance broker.
- Comply with the Occupational Health & Safety Act & the Employment Standards Act

- Incentive can not be used to hire immediate family members
- Can not be receiving government funds from any other source for the same training period *
- Employer must not use placement services to replace existing or laid-off employees*

Job -Match Placement Incentive

- JMPI matches job seekers with employers & provides financial support to help offset the cost of hire and training.
- Up to \$6000 per individual is available - based on individual eligibility, need & training requirements.
- Provides support in identifying and resolving workplace concerns to help with retention

Job -Match Placement Incentive

- Employers must commit to providing relevant training & work experience plan that will help participants achieve their labour market / employment goals.
- Having potential for long -term employment / contract position.
- Providing feedback and assessments of a participants skill set.
- Employers must put the participant on company payroll from day one and provide same employment terms, conditions and benefits for all regular employers.
- Provide a minimum of 20 hours per week during placement period

Canada -Ontario Job Grant

COJG provides employers financial support who want to purchase training for their workforce. Employers choose the individuals & this can include new or incumbent workers.

Eligible training costs include:

- Tuition & other reasonable training provider fees.
- Textbooks, software & other required material such as; training clothing, tools, equipment and disability supports.
- Mandatory student fees
- Exam fees
- Travel costs *

COJG - Contribution

99 employees or under

- The Ministry will contribute 5/6th's of total training costs up to \$10,000 per participant (Employers must pay 1/6th of training)
- Employers who are hiring and training an unemployed individual are eligible for 100% funding up to \$15,000

100 + employees

- The Ministry will contribute 1/2 of total training costs up to \$10,000 per participant (Employers must pay 1/2)

Training Supports

- up to \$500 for textbooks, software's and other training materials
- up to \$500 for travel -related costs *

Note: Employers must not ask trainees to cover any of the training costs.

- Connect with your local Employment Ontario site
- Fill out the Employer Registration Form & send in required documents (WSIB, Third-Party Liability)

Best Practices

- Get us involved before you send out the job posting
- Let us know your real needs - including what deal breakers you have
- Give us as much information as possible about the position (including COVID 19 precautions in place)
- Provide feedback on candidates we send your way
- If you are unsure, ask & don't forget about us!
