Elections are over, however uncertainty still reigns in the House of Delegates. As of now, the Republicans hold a 51-49 lead in the House of Delegates. Why is this important? Because party control will affect committee assignments and leadership. While the election has improved our chances of getting our bill out of the House subcommittee, we continue to face opposition in both the Senate and House.

Proposed legislation has been drafted by VCNP and is currently in legislative services awaiting bill number assignment. Our bill patron is Delegate Roxann Robinson. Delegate Robinson has demonstrated extraordinary leadership and commitment to our issue by facilitating stakeholder group meetings between the VCNP, the Medical Society of Virginia (MSV) and the Virginia Hospital and Healthcare Association (VHHA) over a 6-month time period. Our purpose was to build consensus around removal of practice barriers created by the collaborative practice agreement requirement. Regrettably, consensus building was thwarted due to the opposition's desire to maintain the status quo.

Salient points of our proposed bill are highlighted below.

- Removal of the collaborative practice agreement following 1040 hours post licensure practice period
- Broadened collaborating provider list to include NPs in addition to MD/DO during the required collaborative period
- Removal of references to "team care"
- APRN titling protection

The proposed bill language has been discussed with the AANP. While they cannot openly support our approach due to retention of regulation by the Joint Boards, they acknowledge understanding of what we are up against in Virginia.

Keep in mind that our legislative approach has been influenced by the political landscape, which necessitates that we take an incremental approach to removal of practice barriers. While the proposed bill retains the Joint Boards, please understand that this is only because the political environment will not support passage of a Full Practice Authority bill at this juncture.

As the 2018 General Assembly session is approaching, we are running short on time to meet with legislators in the district. Legislator meetings are essential to develop relationships and share your patient care personal stories. A strong grass roots campaign is necessary to ensure success and we need your help to identify potential legislators sympathetic to our issue.



Important Updates About Renewing Your Annual VCNP Membership

Most of our VCNP members renew annual membership each August, and a smaller number of our members renew their annual membership each February. VCNP is making the annual September 1 – August 31 membership the norm for all of our members. This transition will help streamline effort and costs associated with our membership processes and reduce confusion about membership renewals that sometimes occurs with registering for the annual conference each winter.

For members who renew each August, nothing changes! Thank you for continuing to renew your membership at our rate of \$150 per year! Please renew each year before September 1 to insure the is no interruption to your membership!

For members who renew in February each year, your renewal this year will be slightly different. This February, your renewal will be for 18 months instead of one year, moving your next membership renewal to August of 2019. Instead of the annual \$150 annual membership rate, renewal in February will be prorated at \$225 on a one-time basis for the extended 18 month membership. In August 2019, your annual membership dues revert back to the standard annual rate of \$150 per year. While there is no difference in the overall annual rate, your membership with VCNP will be for 18 months, lasting from February 2018 through August of 2019.

VCNP has awarded a \$2,000 scholarship to Cindy Fagan, DNPc, RN, FNP-BC, on Saturday, November 4 during the Virginia Nurses Foundation Gala at The Omni Homestead Resort.

Fagan earned her BSN and MSN degrees from Virginia Commonwealth University and is currently a Doctorate of Nursing Practice candidate at the University of Virginia. Her anticipated graduation date is May 2018. Fagan's nursing career spans 31 years, with 18 of those years spent in the nurse practitioner role.

"Cindy's commitment to the veterans she works with and to her position here at VCNP are inspiring," said Christine Daley, MN, RN, ANP, president of VCNP. "We look forward to seeing her continue to grow within this profession and this organization."

With roles in primary care, hospitalist, endocrine and infectious disease, Fagan has varied experience. She is currently settled in the Veterans Health

Administration, having spent the past 12 years serving our nation's veterans at the Hunter Holmes McGuire Medical Center. Fagan also serves as the government relations chairperson for VCNP and has also served as past-president of the statewide organization. Her responsibilities within that role are to advance VCNP's mission and goals in terms of legislative initiatives including policy development, strategies and tactics, engaging member participation in advocacy activities, garnering stakeholder support, coalition building and coordination of legislative efforts throughout the state.

VCNP's scholarship, which was awarded for the first time in 2010, honors nurse practitioners and their passion for quality health care. To date, VCNP has granted \$9,000 in total to scholarship winners. The scholarship is funded through the generous membership participation of the basket raffle that occurs each year at the annual conference. Scholarship applicants must be members of VCNP who are enrolled in a doctoral program in the Commonwealth of Virginia. Applicants also must have completed 50 percent of the required hours of graduate study and exhibit academic excellence and a commitment to advanced practice nursing with strong clinical and leadership abilities.

PROMETHEAN GROUP CLINIC

Dr. Ameanthea Blanco-Knezovich, DNP, FNP-C in coordination with Dr. Jessica Parrott, DNP, CPNP, CNE have formed Promethean Group: a 501(c)(3) non-profit mobile family practice clinic that is student and volunteer run for the homeless and underserved populations in Hampton Roads. Both have acquired their MSN and nurse practitioner degrees from Old Dominion University. Additionally, both graduated from the inaugural DNP class of 2010 at Old Dominion University. Professionally, they and both current faculty members for the Family Nurse Practitioner Program at South University's Virginia Beach Campus.

Dr. A. Blanco-Knezovich is the current Executive Director and Dr. J. Parrott is the current Clinical Director for Promethean Group. Since its establishment in June of 2017, it has held numerous clinics for the homeless and underserved populations. The Promethean Group mobile medical clinic travels to different homeless shelters, churches, and coordinated events to provide primary medical care to populations in need. Promethean Group sees patients of all ages to conduct family practice medical care on children and adults at no cost to patients.

Promethean Group emphasizes intercollaboration within all fields to provide competent, comprehensive care for their patients. We collaborate with other community professionals and university programs onsite at our clinics to deliver the following: medications, mental health counseling, haircuts, occupational therapy, chiropractic care, physical therapy, and individuals to assist in applying for insurance, substance abuse treatment, and transitional housing. Through this collaboration, clinics have serviced an average of 30 people for acute and chronic medical care issues and prescribed medications within a four-hour time frame at Beach Fellowship and Judeo-Christian Outreach Center.

Dr. A. Blanco-Knezovich, synchronizes the medical clinic and event participants, and Dr. J. Parrott orchestrates student/faculty participants, emphasizing educational outcomes of students and ensuring consistent patient flow. Collaboration includes multiple professionals working in solidarity to provide competent and compassionate care. Volunteers include clinic set up and breakdown by Navy volunteers, and students and faculty from respective programs and fields of study. A legal studies program registers, reviews clinic duties, and consents with volunteers. Healthcare management program students' aide in patient registration, patient consent, and chart movement throughout the clinic. Undergraduate nursing students complete patient intakes, obtain vitals, and review discharge instructions. MSN-FNP students conduct evaluations, initiate treatments, and prescribe medications for patient's acute and chronic medical issues. Occupational therapy assistance (OTA) students dispense hygiene kits they created from their hygiene drive efforts on campus, and work in conjunction with chiropractic care volunteers to review back stretches for back pain due to patients sleeping on the ground. The physical therapy assistant program conducts foot checks/assessments to monitor for neuropathy in patients due to inappropriate footwear, a problematic occurrence with chronically displaced individuals. The mental health counseling program conducts miniature cognitive exams during intake due to the higher incidence of mental illness within this population.

During this event students also have had the opportunity to work with multiple organizations from the community to provide an all-inclusive experience for patients, while instilling interprofessional collaboration. Promethean Group provides supplies the medical equipment and has established an electronic medical record for charting and electronic prescription that the students utilize. The students must adhere to the Wal-Mart Pharmacy's medication formulary that provided \$4 and \$9 prescriptions, as Promethean Group has secured external funding for these medications. Impact Mental Health attends and allows students to refer patients to behavioral health services, transitional housing, application for accessible insurances, and substance abuse support. Dynamic Chiropractic Care is onsite to educate on back stretches, and the staff of Virginia Beach Beauty and Barber Academy attend to provide haircuts for both men and women.

Promethean Group has also had the privilege in participating in the Buffalow Family and Friends Back to school event to provide free student school physicals for Title One Chesapeake, South Norfolk Public School students. BSN students acquired vitals and vision screenings while FNP students completed school entrance exams. This event was also collaborated with the Chesapeake Health Department who were present to provide free vaccinations for students.

The response has been overwhelmingly positive by students of the university programs, and has allowed the students to start giving back in their field of study and interest. Many of the MSN FNP students who have previously participated and recently graduated have continued to volunteer after graduation. The Promethean Group experience allows new graduate nurse practitioners and experienced nurse practitioners the opportunity to give back within their area of specialty.

Feedback from the homeless patients served has been overwhelmingly, and consistently positive. Attendees have stated that they are: "eager to share the wonderful and caring experience with family and friends, who know we are in need of such services".

Promethean Group is a nurse practitioner led group that is compliant with Virginia regulations, and has a practice agreement with a local collaborating physician. The current regulations in Virginia for advanced practice nursing has been limiting to the growth that the clinic could potentially achieve. Drs. A. Blanco-Knezovich, and Dr. J. Parrott recognize this and have met with State Senator Bill DeSteph, Congressman Scott Taylor and the health advising staff of Senator Tim Kaine to lobby for full practice authority. Full practice authority for advanced practice nurse practitioners is a necessity for the needs of our current healthcare system, and particularly for the needs of vulnerable populations.

PMP SUSTAINABILITY DISCUSSION FINAL DECISION: NO ACTION FOR NOW

This year the General Assembly instructed Virginia's Joint Commission on Health Care to study the sustainability of the Prescription Monitoring Program (PMP) and identify potential funding sources for its future operation. Since 2007, the PMP has been funded solely by money from a court settlement with the Purdue Frederick Company, Inc., of \$20 million, and these funds are expected to run out sometime between 2027 and 2031.

Richard Grossman, our lobbyist and I were invited by the JCHC to participate in a stakeholder meeting in September to address the findings of their study and to offer a response VCNP. Several policy options were discussed at the meeting that were later presented to the Joint Commission. One option presented was to increase the licensing fees of health professions required to register with the PMP by up to \$30 annually. Other options included a point-of-sale tax on all controlled substances or an assessment on health insurance premiums.

Both VCNP and MSV submitted comments to the Joint Commission regarding these options asking that no action be taken at this time because funding is sufficient for the foreseeable future. We suggested a stakeholder group be formed to determine the future needs and functionality of the PMP and that an educational campaign regarding the benefits of the PMP be initiated for healthcare professionals. At the November 21 meeting of the Joint Commission agreed to take no action for the time being but declined to continue the work of the study group.

VCNP COMMENTS TO THE JOINT COMMISSION ON HEALTH CARE ON PMP SUSTAINABILITY

The Virginia Council of Nurse Practitioners (VCNP) is the statewide professional organization for all nurse practitioners licensed in the Commonwealth of Virginia. Approximately 7,700 licensed nurse practitioners provide primary and specialized care to Virginians. We are registered nurses with advanced skills and clinical experience, prepared at the masters or doctoral educational level. We can assess, diagnose, order and interpret diagnostic tests, treat, prescribe and refer patients using evidence-based patient-centered care. We also provide a wide range of preventive and acute health care services. Nurse practitioners in Virginia are licensed jointly by the Boards of Nursing and Medicine.

The staff report, presented to the Joint Commission on September 19, states for PMP basic functionality, court settlement funds are anticipated to run out between 2027 and 2031. After reviewing the report and weighing all the options presented, VCNP feels that the need to act at this point is premature and not necessary.

Instead, VCNP recommends the following:

- The various stakeholders and the Joint Commission should take additional time to identify the future needs and functionality of the PMP, including integration into other health data systems (electronic prescribing, electronic health records, etc.) to better estimate future costs and needs.
- The Department of Health Professions should work with the various stakeholders and licensing boards to educate the public on the need, goals and cost of the PMP to garner additional support for future funding efforts.
- Increased functionality and integration comes with significant costs to Nurse Practitioners who are also facing substantial mandated costs by the state in terms of multiple licensing fees, practice agreement fees, and technology upgrades for electronic prescribing.

On another issue, VCNP was asked to participate in an E-Prescribing Workgroup to determine how the requirement for e-prescribing for all providers by 2020 (which passed in the 2016 session) will be implemented.
