

Projected Pierce County Homeless Population Growth




Race (with averages for general population in orange)






















People Homeless in Pierce County - Demographic Data - 2017 year to date

Months Homeless




Disability Detail - Percent of clients self-identifying each disability.




Crisis Service Utilization in Past Year
