Keynote: Identification and Treatment of Older Adults: All Providers have a Role.

Late life abuse of alcohol, tobacco, medications and illicit drugs often goes unrecognized by many healthcare providers. Even when there is suspicion or recognition, many providers feel ill-equipped to address these issues. Treatment starts with the first provider that a patient encounters. It is important to identify and participate in older adults care. There are established treatments for older adults that everyone can learn to deliver. It is important to consider that older adults can reduce their use and will greatly benefit in their health and well-being.

Opiates: Use and Abuse

Mark L. O'Brien, Director of Opioid Overdose Prevention and Treatment, Baltimore City

Like much of the country, Maryland is in the midst of an epidemic of opioid addiction and overdose deaths. Over 2,000 people lost their lives to overdose in Maryland in 2016. The disease of addiction knows no boundaries and affects Maryland residents of all ages, including seniors. This presentation will discuss the causes and magnitude of the epidemic, demographic characteristics of its victims, including age, and available options for treatment and harm reduction. It will include a demonstration of the way to respond to an opioid overdose using the overdose reversal medication naloxone.

Two case studies will be presented in a dramatization format. Each study will address a different age group within the senior population and characteristics that may present frequently within each cohort. Our "older" senior is dealing with issues related to alcohol abuse while a "younger" senior is seen dealing with issues related to substances of abuse such as prescription medication and illegal drugs. Both roles play demonstrate the importance of an Integrated Care approach in identifying and treating substance use.
