

- All boats (club's, facility's and privately owned) **must be off the boat racks** by Sat. October 15 even if you are leaving your boat in camp for the off season.
- There will be no off season fee accessed provided that your boat is out of camp by Sat. Oct. 15
- All club and facility holder's boats that are being left in camp must be in the cabin, on the tent platform, under the facility or at the Pavilion by Oct. 15.
- Any privately owned boats that are being left over the off season (Oct. 15 to May 1) will be assessed a \$200 off season fee and must store their boats at the Pavilion.
- All privately owned boats must be placed at the Pavilion by Oct. 15
- Boats may start being stored at the Pavilion as of Sun. Oct. 9
- All boats being stored at the Pavilion must be removed by May 1, 2017
- After Oct. 15, you will not have access to your boat until May 1.
- The camp is not responsible for any boats that are left in camp during the off season.

### 12 Vital Camp Rules

- 1. Must sign in each day that you are in camp: you, your family, your guests.
- 2. Everyone is required to pay the daily/guest fees or have a season pass.
- 3. A guest is defined as someone who is either visiting an ACA member, or someone who is checking out the camp prior to joining. The same guest may only utilize the camp twice and will then need to join the ACA in order to continue coming into the camp.



- 4. Pets are not allowed in camp.
- 5. Cable gate on Seven Lakes Drive should always be locked, the very least, put back up and se cured.
- 6. Dishes may not be washed in either bathroom, you can either use the spigots or bring water from the bathroom back to your facility.
- 7. Swimming is only allowed in the designated swim area and only if there is a lifeguard or 2 adults, not off the boat docks.
- 8. Children must be monitored at all times while in camp or at the swim and/or boating docks.
- 9. No eating, drinking (especially alcohol), or fishing is allowed at the swim dock.
- 10. Fishing is allowed on the boating docks and fishing lines must be pulled in whenever a boat is approaching the dock or leaving from the dock.
- 11. No swimming or boating is permitted after dark.

### Closing of Facility Check Off List To be done by October 15th Clean cabin thoroughlystove, refrigerator, microwave, floors, cabinets Unplug ALL electrical appliances, especially the refrigerator. Leave refrigerator and freezer doors open Remove all food items from the cabin Remove all paper goods from the cabin Make sure all the windows are securely closed Make sure all of the lights are off Make sure to lock the cabin door. Remove all needed items out of facility prior to Oct. 15—you will not have access to your facility after this date. Suggestion: if you are leaving clothes in the cabin, you may want to secure it in a storage container with a cover on it. Closing of Tent Platform Check Off List To be done by October 15th Remove tarp by Oct. 15 Clean all appliances thoroughly, especially the refrigerator. Cover the refrigerator with a tarp and fasten tightly Make sure the refrigerator and freezer doors are tightly secured and cannot be opened Remove all items that are not secure from your tent platform Make sure to secure all items on your tent platform, especially any boats left on it

Remove all needed items from the tent platform prior to Oct. 15—you will not have ac-

A club's defective roof was finally replaced, thanks to the tireless work of a previous B&G Chairman. He also arranged for ongoing extermination service, which we all appreciate!

#### **Aqua Invasives**

The Conservation Committee is announcing a new partnership with Hudson River Sloop Clearwater to manage Aqua Invasive Species (AIS) in Lake Sebago. AIS grow so rapidly that they overtake the native plants and animals, wreaking havoc on the ecosystem and, in some cases, impeding recreational activities such as paddling and swimming.

Aqua Invasives, such as hydrilla, have infested and clogged the Croton River, and other invasives have ravaged parts of Lake George in upstate New York, costing hundreds of thousands of dollars to control. At Lake Sebago, AIS that have been identified thus far include Chinese mystery snails and water milfoil. As much as some of the invaders enter the lake naturally, transported by the ducks and other wildlife, humans have also been implicated in the spread of AIS, as the invaders "hitchhike" on boats, including canoes, kayaks, and even inflatable rafts and SUPs, making paddlers carriers as they journey from one water body to another.

Just as the Conservation Committee has tried to eradicate the barberry from growing on land around the lake, now it is working to manage the invasives growing in the lake. A newly formed Aqua Invasives Team is seeking input from the ACA community: What can we do at camp to manage these noxious invaders? Proposals thus far include a Washing Station, where boats from other water sources can be checked, cleaned, and dried before entering the lake. Furthermore, plans are underway to survey Lake Sebago in order to understand exactly which AIS are currently growing.
