The Arctic has been the responsibility of the U.S. Coast Guard since 1867, when the Revenue Cutter Service became the face of the federal government in Alaska. We include a visualization of a proposed Polar Exploration and Research Exhibit as an example of how our exhibit designers will integrate Coast Guard history with interactive features, creating an unforgettable visitor experience.

This year marked great advances in our design efforts. The National Coast Guard Museum Association, Inc. is now ready to build a museum that will inspire and instill a sense of pride in the U.S. Coast Guard for all Americans. In Memoriam **ARNOLD PALMER** 1929 - 2016

The National Coast Guard Museum mourns the loss of one of its Honorary Chairmen, **ARNOLD PALMER**

As a former Petty Officer in the U.S. Coast Guard, the legendary professional golfer was a staunch supporter of the National Coast Guard Museum.

Palmer was the first golfer to win the Masters Tournament four times and is universally regarded as one of the greatest players in the history of men's professional golf, winning 92 tournaments during his career. He enlisted in the United States Coast Guard in 1950 as a Yeoman and continued to serve until 1953.



Palmer's commitment to the Coast Guard continued throughout his life. He joined the National Coast Guard Museum Association as an honorary chair. In that role, he was instrumental in working with the Association's executive committee and board members to establish

the country's first-ever National Coast Guard Museum to honor the commitment, accomplishments and sacrifices of his fellow Coast Guard service members.

2016 Achievements...

Design Milestone

“Today marks the most important measure of progress to date since the idea for a National Coast Guard Museum was first conceived.”

With those words on December 16, 2016, Richard Grahn, President of the National Coast Guard Museum Association (NCGMA), captured the excitement over the museum’s new architectural designs, which were unveiled to wide public acclaim.

The initial design concepts for the museum were revised to address both opportunities and needs of building on the waterfront site. NCGMA and officials from the Federal Emergency Management Agency (FEMA), the U.S. Coast Guard, the Connecticut State Department of Energy and Environmental Protection (DEEP), and the U.S. Army Corps of Engineers worked diligently to consider the design elements necessary to satisfy all applicable environmental regulations.

NCGMA is delighted to provide a glimpse of a world-class museum to be built on the New London waterfront. Final design elements will be refined through environmental review and public comment, which is underway and should be completed in 2017.

Museum Thematic Content

The National Coast Guard Museum will consist of three exhibit floors telling the rich and powerful stories of this remarkable armed service and its corps of service members who for more than 226 years have been Always Ready to serve our nation – befitting the motto *Semper Paratus*. Each wing of the museum will host exhibit galleries pertaining to our Coast Guard’s missions: Enforcers on the Seas, Defenders of Our Nation, Champions of Commerce, Protectors of the Environment, and Lifesavers Around the Globe.

A fourth floor will house the STEM Learning Center that will engage museum visitors and area students in science, technology, engineering and mathematics activities with hands on, immersive experiences through the planned classroom, auditorium, and simulator center. The rooftop and waterfront will display outdoor exhibits for hands-on fun and learning.

Interior Design and Visitor Experience

The National Coast Guard Museum will be a learning center filled with sophisticated interactive exhibits to showcase the air and sea navigation technology that has carried the U.S. Coast Guard into the 21st Century.

The Museum Exhibit Advisory Panel (MEAP), a panel of distinguished Coast Guard history champions, representing Coast Guard affiliated organizations with over 50,000 members, worked with a world-renowned museum exhibit design firm to develop the proposed themes, stories and artifacts to be displayed at the National Coast Guard Museum.

Exhibits, simulators, technology and artifacts will be on display throughout the museum. STEM components will be integrated into the exhibits to create a lasting learning experience. Additionally, the museum STEM Learning Center will complement the exhibits and ensure a stimulating and interactive museum experience for every visitor.

Educators, working with our exhibit designers, will develop an experience where visitors choose from a menu of options to explore the museum. They may choose to explore on their own, be guided by a Virtual Shipmate, or participate in a simulated Coast Guard Qualification Program.

SECRETARIES' CIRCLE MEETS WITH CONGRESS

May 2016

Secretary Andrew Card, Secretary Rodney Slater, and other members of the Secretaries' Circle of the NCGMA joined Coast Guard Commandant Paul Zukunft and senior Congressional leaders for a Capitol Hill update on the progress of the first national museum to honor the men and women of the United States Coast Guard.

The Connecticut delegation reported legislative success in lifting restrictions on federal funding for the project.

Master of Ceremonies, Admiral James M. Loy, USCG (Ret.), former Commandant of the Coast Guard and Deputy Secretary of Homeland Security, told members of Congress that "preserving the history of the U.S. Coast Guard must be done. I know first-hand that every Cabinet member who has overseen the Coast Guard shares my sentiments and is delighted to sign on to be a part of this elite Secretaries' Circle."

The Secretaries' Circle is made up of former federal cabinet members who oversaw the Coast Guard in the Departments of Transportation and Homeland Security and are especially committed to the National Coast Guard Museum.

ALEXANDER HAMILTON AWARD


December 2016

The National Coast Guard Museum Association, Inc. presented its 2016 Alexander Hamilton Award to Coast Guard veteran J. David Power III. The eponymous founder of J.D. Power and Associates, Inc. served as an officer aboard the Coast Guard icebreaker EASTWIND during the mid-1950's. The NCGMA created the Alexander Hamilton Award in recognition of those who perform extraordinary work to honor the men and women of the U.S. Coast Guard.

LT Power was honored in recognition of his years of outstanding service in support of the National Coast Guard Museum. He is the second recipient of this prestigious award, joining James J. Coleman, Jr., Chairman of the Board of Directors of the National Coast Guard Museum Association, who was presented with the Alexander Hamilton Award in 2015.



The Best Make History Every Day

On any given day, the men and women of the Coast Guard perform their duties to protect our nation with dedication and distinction - making history every day within the five main missions of the U.S. Coast Guard - missions that will provide the major themes for the National Coast Guard Museum. Each of our wings will be dedicated to one mission, and as the following recent accomplishments prove, the constant dedication to these missions is the key to the Coast Guard's success: past, present and future.

ENFORCERS ON THE SEAS

The Coast Guard continued its legacy as the nation's maritime law enforcement agency in 2016, securing and managing our borders, enforcing national and international laws on the high seas, inland waterways, and the Great Lakes.

In excess of 179 metric tons of illegal drugs were interdicted by the U.S. Coast Guard in 2016, and more than 500 suspected smugglers were detained. The Coast Guard Cutter HAMILTON intercepted more than 26 tons of cocaine and detained 100 suspects on her maiden voyage!

LIFESAVERS AROUND THE GLOBE

The U.S. Coast Guard responded to more than 16,000 Search and Rescue cases, saving 3,536 lives in 2016. The men and women of the Coast Guard faithfully executed the National Search and Rescue Plan in conjunction with international, federal, tribal, state and local authorities.

PROTECTORS OF THE ENVIRONMENT

The Coast Guard coordinated responses to oil and other hazardous materials spills in navigable waterways, serving as Federal Maritime Security and On-Scene Coordinator. The Coast Guard also continued to strengthen America's presence in the Arctic, enhancing our nation's ability to meet the challenges of operating in this burgeoning international seaway.

DEFENDERS OF OUR NATION

The Coast Guard performed maritime interdiction operations, combated maritime terrorism, provided port security and coordinated maritime defense in the United States and around the globe.

Coast Guard Patrol Force Southwest Asia (PATFORSWA), comprised of six inland class patrol boats, has provided an exclusionary protection zone for Iraq's offshore oil fields since 2002.

CHAMPIONS OF COMMERCE

The Coast Guard discharged its global responsibility to facilitate safe and secure maritime commerce around the world, and minimize security risks to the nation by screening merchant vessels prior to their arrival in U.S. ports.

More than 131,000 merchant vessels were inspected in 2016, and the Coast Guard maintained more than 47,000 aids to navigation on the nation's waterways to ensure safe transport of more than \$3.2 trillion in economic activity within the U.S. maritime transportation system.
