Release of Liability

Acknowledgment of Risks: I recognize that there are inherent dangers and risks involved in children's day camp activities riding lessons, and/or parties and events which include animal and non-animal activities including, but not limited to the following: 1) Riding lessons on horses or ponies, pony rides, pony workshop, animal grooming, pony obstacle course, equine leading class, animal care class, petting zoo activities and any other animal related activity. 2) Playtime in playground, playing games or sports, any games or other activities associated with day camp or playtime or party time. 3) Swimming, or any other water related activities. 4) Any indoor or outdoor activity which results in exposure to or bites or stings by wasps, bees, fire ants, snakes or any other pests or species indigenous to the area. 5) Any activity of any kind while enrolled in or visiting Rosaire's Riding Academy Kidscamp 2007 or riding lesson or attending any party or event held at or provided by Rosaire's Riding Academy & Pony Rides L.L.C.

I realize that unexpected incidents may happen at any time and that there are risks involved at all times and in all situations even under adult supervision. I expect my child to behave in a responsible manner and to obey all safety rules which are posted at the tack room and which are discussed at the orientation meetings held on the first day of each day camp session. I will supervise my child while attending parties or events held at or provided by Rosaire's Riding Academy & Pony Rides L.L.C. or I will see that they are under the adult supervision of the host or hostess of the party or event or another responsible adult.

Express Assumption of Risk and Responsibility: In recognition of the inherent risks of any activities I and my minor children for which I am responsible, will engage in, I confirm that I am (we are) physically and mentally capable of participating in the activity and using the equipment. I (we) (my children) participate willingly in all activities offered in the day camp program, party or event, in full understanding of the risks and dangers involved. I (we) assume full responsibility for personal injury, accidents, or illnesses, including death and any expenses incurred. I (we) assume full responsibility for damage or loss of my/our personal property.

Release of Liability: I, on behalf of myself, my children, and/or legal ward, or other parent, all heirs, administrators, representatives, assigns, or estates do hereby release and hold harmless Rosaire's Riding Academy & Pony Rides L.L.C., Party Animals Petting Zoo L.L.C., Ellian Rosaire, Kazimierz Dymek, and any or all heirs, and any and all landowners of any land on which above stated activities take place for any accidents, injuries, illnesses, including death or any expenses incurred while participating in any day-camp, riding lesson, or event or party held at or provided by Rosaire's Riding Academy & Pony Rides L.L.C.
