Confidentiality Agreement

AGREE

- a) Not to discuss and disclose information regarding current business trading and partnerships. Such disclosure (through whatever form of communication) will necessitate the disclosure of confidential information concerning the business and/or affairs of 1230 The Women's Company Ltd and Jo Soley Business Angel, as Jackie & Jo, Women Love Business London Events, its members and visitors
- b) Jackie & Jo, Women Love Business London Events requires such disclosures to be treated in confidence and to be protected in accordance with the Terms of this Agreement.

IT IS AGREED as follows:

1. Information disclosed under this Agreement may include, but not be limited to, commercial, financial, technical, operational or other information in whatever form (including information disclosed orally or through a web site) which concerns the business and/or affairs of Jackie & Jo, Women Love Business London Events and is of a confidential nature, including any such information disclosed prior to the date of the Agreement
2. The above named will:
 - 2.1. adhere to the Chatham House Rule at all times
 - 2.2. keep in confidence any Confidential Information disclosed to her within the Jackie & Jo, Women Love Business London Events and will not disclose that Confidential Information to any person, without the written consent of each member and visitor at a Jackie & Jo, Women Love Business London Events meeting;
 - 2.3. use the Confidential Information disclosed within the Jackie & Jo, Women Love Business London Events only for the purposes for which it was disclosed;
 - 2.4. ensure that all people to whom the Confidential Information is disclosed under this Agreement are aware of the Terms of this Agreement; and

- 2.5. not make copies of the Confidential Information disclosed at the meeting apart from their own action items;
- 2.6. not disclose any information shared by individuals/companies attending Jackie & Jo, Women Love Business London Events and open evenings
- 3. The overleaf named will keep the existence, nature and content of this Agreement confidential, together with the fact that discussions are taking place concerning the business and affairs of Jackie & Jo, Women Love Business London Events
 - 3.1. This applies to all information disclosed during Jackie & Jo, Women Love Business London Events meetings and open evenings.
- 4. Paragraphs 2 and 3 shall not apply to:
 - 4.1. information in the public domain other than through a breach of this Agreement
 - 4.2. information lawfully in the possession of the recipient before its disclosure under this Agreement took place;
 - 4.3. information obtained from a third party who is free to disclose it;
 - 4.4. information which a party is requested to disclose and if it did not could be required by law (including a regulatory body) to disclose
- 5. No licences or rights under any patent, registered design, copyright, design right or any similar right belonging to a party are implied or granted under this Agreement.
- 6. The obligations and restrictions in this Agreement will last for a period of ten (10) years from the date of the last disclosure of Confidential Information under this Agreement
- 7. Jackie & Jo, Women Love Business London Events will request either the:
 - 7.1. return all copies of the Confidential Information to the disclosing party or parties, or
 - 7.2. destruction and confirmation in writing to the disclosing party or parties that this has been done
- 8. The disclosure of Confidential Information under this Agreement does not oblige any party to enter into any further agreement with any of the other parties
- 9. The provisions of this Confidentiality Agreement shall be severable in the event that any of the provisions are held by a court of competent jurisdiction to be invalid, void or otherwise available.
- 10. This Agreement is governed by the Law of England and Wales
