

**FYPON "PICK YOUR FYPON!" SOCIAL MEDIA SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY. A purchase will not increase your chance of winning a prize. Open to U.S. residents, who are 18 and older (if the age of majority is older than 18, you must be the age of majority within your state to be eligible to win). This Sweepstakes is not sponsored or endorsed by Facebook.

1. **Entry Period:** The Pick Your Fypon! Social Media Sweepstakes ("Sweepstakes"), sponsored by Fypon ("Sponsor"), begins on January 30, 2017 at 12:00:01 a.m. Eastern Time ("ET") and ends on March 5, 2017 at 11:59:59 p.m. ET (the "Sweepstakes Period"). Sponsor's computer is the official timekeeping device of the Sweepstakes.
2. **Eligibility:** Entry into the Sweepstakes is open to permanent legal residents of the 50 United States and the District of Columbia ("D.C."), who are 18 years or older at time of entry ("Entrant"). Limit one (1) weekly entry per person or Facebook account during the Sweepstakes Period; if more than the allowed entries are received from an individual Entrant or Facebook account, all such entries submitted will be disqualified and will not be included in the prize drawing described below. All weekly entries must be received by February 5, 12, 19, 26 and March 5, 2017 at 11:59:59 p.m. E.T.
4. Entry must be made by an individual person; use of script, macro, or other automated systems to participate is prohibited and will result in disqualification. In the event of a dispute as to the identity of an Entrant, entries will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry. The "authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, on-line service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted e-mail address. being the authorized account holder. Incomplete, unreadable, or unintelligible entries will be disqualified.

Odds of winning a prize depend on the number of eligible entries received.
