Dear Ann Arbor Rotarian:

This letter is your dues bill for the 2018-2019 Rotary year. The Rotary year starts on July 1 and ends on June 30.

Amount: Dues for Active members are based on age as of July 1, 2018. Members between 40 and 69 years old owe \$380. Members 70 and over owe \$350 although those who have been awarded Emeritus status owe \$190. Dues for members who have not reached their 40th birthday are \$230. Honorary Rotarians and Inactive Emeritus members are exempt from dues.

How to pay: In addition to the traditional payment in full by check or credit card, we are now offering a monthly payment plan, either by credit card or through checking account transfers by ACH (Automated Clearing House) debits. In any of these options, the process begins with the completion and submission of the enclosed 2018-2019 Dues Payment Form.

When to pay: Your Dues Payment Form is to be submitted by **Wednesday, June 13**. All you need to do by that date is complete the attached form and give it to Dave Keosaian, John White or Barbara Eichmuller at a weekly luncheon meeting or mail it to the club at P.O. Box 131217, Ann Arbor MI 48113-1217. If you wish, you can email your choice to Dave at dkeosaian@msn.com.

To pay by check: Please make it out to "Rotary Club of Ann Arbor" for \$380, \$350, \$230 or \$190, as appropriate. You can submit your check with your Dues Payment Form at any time in advance of the due date.

To pay by credit card or ACH: Mark the Dues Payment Form with your choice of a single payment or monthly installments and submit it by the due date. We are currently working with our provider of financial services to set up these methods of payment. You will be contacted when it is time to provide your credit card number or checking account information.

Thank you for your timely attention to this matter. Beyond the need for some certainty in our budgeting, the primary reason we collect dues before the year begins is that our club is billed for dues to RI and the district based on the number of Rotarians on our roster as of July 1.
