RE: CCMS Call for Officer Nominations

Dear CCMS member,

The 2018 CCMS nominating committee will present its slate of CCMS officers for 2018-2019 to the membership this spring, at least 30 days prior to this year's annual meeting on May 19th. The nominating committee would like to invite members in good standing to submit candidates for review by the committee.

According to CCMS bylaws, candidates proposed by a CCMS member to the committee must be proposed in writing, including qualifications, at least 60 days before the annual membership meeting (March 19th). Nominations from the floor at the annual meeting are also accepted from a member in good standing and with the consent of the nominee.

The officers of this Society shall consist of a president, vice president, secretary, treasurer, and one officer/director at large. At the discretion of the nominating committee up to two additional directors at large can be nominated to the Board of Directors. The nominating committee will also present candidates for delegate and alternate delegates to the Florida Medical Association 2018 Annual Meeting, August 3-5 in Orlando.

Only active members of the Society shall be considered (does not include adjunct, associate, retired, or honorary) for office. Candidates for president shall have served a minimum of one year on the Board of Directors. Candidates for vice-president shall have served either on the Board of Directors or chaired the PAC or a committee for one year. Those elected shall assume office at the close of the annual membership meeting for a term of one year.
