Union Gas - GIF/IESO Whole Pilot Termination Notice

Please be advised that Union Gas (UG) will be terminating enrollment in the following enhancements to the Home Reno Rebate program:

1. The IESO Whole Home Pilot (WHP):
 - Last eligible D assessment enrollment date is **September 30th 2018**.
2. The Government of Ontario Green Investment Fund (GIF) program:
 - Last eligible D assessment enrollment date is **October 31st 2018**.

History and Background:

- UG launched the GIF program in July 29th 2016
- Extended rebates to homes heated with oil, propane or wood as well as natural gas customers of other gas utilities.
- Increase in rebate amounts for most of the measures
- Added ASHP as a secondary heating source (\$500)

- UG introduced the IESO WHP in May 29th 2017:
- Extended rebates to electrically heated homes
- Extended IESO Heating and Cooling program rebates through HRR (Air condition and Furnace ECM rebates)
- Offered rebates for electric appliances (Fridge, AC, Humidifier...etc)
- Increase in rebate from \$500 to \$600

What will Change:

IESO Whole Home Pilot Termination

With the termination of the WHP, the following will take place:

- UG will stop offering Home Reno program rebates to electrically heated homes.
- UG will stop offering rebates for appliances (Fridge, Freezer, AC...etc.)
- UG will stop offering rebates for Heating and Cooling program (Furnace ECM, CAC SEER18) (However, homeowners can still apply for those rebates through their HVACs)
- Non-electrically heated homes installing ASHP as a secondary heating source will still be offered 500 rebate until October 31st, 2018.
- Assessments rebate will be reduced to \$550 from \$600

***Please note that any D assessments completed starting October 1st will not be eligible for the IESO WHP rebates (No exceptions will be allowed)**

GIF Program Termination

With the termination of the GIF program, the following will take place:

- Union will stop offering Home Reno program rebates to Oil, Propane & Wood heated homes
- Natural Gas customers of other gas utilities (for example Kitchener Utilities)
- UG customers who are not using a natural gas furnace/boiler as main heating source for the whole house.
- Conversion from and to natural gas will not be allowed
- ASHP as a secondary heating source for non-electric homes will be ending on October 31st, 2018.
- Some of the Home Reno rebates will be reduced (see table below)

***Please note that any D assessments completed starting November 1st will not be eligible for the GIF rebates (No exceptions will be allowed)**

New Home Reno Rebate Program – November 1st, 2018

Starting November 1st 2018 UG will revert to the initial Ontario Energy Board (OEB) approved program that was running before the launch of the GIF & WHP with few exceptions (see below) and will continue until the end of 2020.

Customer Qualification:

- **Only** active UG customers with existing natural gas furnace/boiler as main heating source qualify to participate in the Home Reno Rebate program
- Oil, propane, wood and electrically heated homes as well as natural gas customers of other utilities can't participate in the HRR program. Homeowners converting to natural gas can't participate in the HRR program.
- Home types must be Live/Own, detached, semi-detached, town house or mobile home located in the UG franchise area.
- Must complete a pre renovations and a post after renovations are complete.
- Must complete at least two eligible renovations.
