

Things to Consider When Filing Your Tax Return

HEALTHCARE COVERAGE

The health care law known as the Affordable Care Act (ACA) brought changes to the federal income tax return that individuals file each year. 2014 tax returns were the first time taxpayers were required to report health care coverage, and provided premium tax credit for eligible individuals who purchased coverage through the Health Insurance Marketplace.

INCOME BASED RESOURCES

Individuals that earn \$58,000 or less may be eligible to receive access to free tax preparation software or free tax preparation by IRS certified tax preparers. Some individuals may also be eligible for the Earned Income Tax Credit or Child Care Tax Credits.

- [Free Tax Return Preparation](#) The IRS' Volunteer Income Tax Assistance (VITA) program offers free tax help to people who generally make \$53,000 or less, persons with disabilities, the elderly and limited English speaking taxpayers who need assistance in preparing their own tax returns. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals.
