

# Business Achievement Award Nominations

## Nomination & Selection Process

1. Nominations for the 2018 Simcoe & District Chamber of Commerce Awards will open on June 1, 2018.
2. Nominations should be submitted electronically to [chamber@simcoechamber.on.ca](mailto:chamber@simcoechamber.on.ca) or in person to the Simcoe Chamber office.
3. Each award has specific criteria. When nominating a business, please be sure to address the criteria specifically in your written submission.
4. A business can be nominated for more than one award. However, a separate submission must be made for each award nomination.
5. Written submissions must include the business name, a brief description of their operations and the category they are being nominated for, as well as the year of establishment.
6. Applications will be accepted until August 30, 2018.
7. Selection of the winner for each award will be made by a committee consisting of the Simcoe & District Chamber of Commerce President, board members and general member(s) with the exception of the Inclusive Employer Award which will be selected by Norfolk Association for Community Living.
8. Recipients of each award will be notified prior to the event, however will be asked to keep the results confidential until the announcement is made publicly at the event on October 25, 2018.

## Outstanding Business Achievement Award

The Young Entrepreneurship Award is to recognize and acknowledge any young individual, in Grade 6 through to age 25 (inclusive), who exhibits extraordinary entrepreneurship, energy, inspiration, leadership and/or innovation in their business pursuits in Norfolk County.

The individual will:

- have started a business from scratch rather than acquiring an existing business
- have demonstrated good business standards and ethics
- have demonstrated entrepreneurial innovation, creativity and drive
- be a good corporate citizen and demonstrate involvement in Norfolk County

## Chamber of Commerce Citizen of the Year Award
