The MFP Program has helped move more than 88,000 older adults and people with disabilities out of institutions and back home with appropriate services and supports, but the program now is in critical jeopardy. Twelve state MFP programs already have exhausted their federal MFP grants, and 33 more will do so as well by December 31<sup>st</sup>, effectively ending the program. JFNA's Strategic Health Resource Center (SHRC) has been vigorously advocating for the bipartisan EMPOWER Care Act (S.2227/H.R. 5306), sponsored by Senators Rob Portman (R-OH) and Maria Cantwell (D-WA) and Representatives Brett Guthrie (R-KY) and Debbie Dingell (D-MI), which would reauthorize and improve this valuable program.
