# **Trainers/Speakers**

**Mark Hutchinson**—Mark has been an Extension Professor at the University of Maine since 2010. His research and educational programming has been focused on soil health in diverse cropping systems, especially the effects of compost on soil health in vegetable cropping systems. He has traveled nationally and internationally to teach large scale commercial composting and assist farmers with managing onfarm mortalities with composting. He is also an instructor at the internationally recognized Maine Compost School.

**Athena Lee Bradley**—Athena is the Projects Manager for the Northeast Recycling Council, Inc. She has been in materials management field for more than 25 years. Athena organizes and is an instructor for organics and food scrap management, composting, and manure management trainings, as well as provides technical assistance to businesses, government agencies, schools, and households. She has attended the Maine Compost School and other compost operator trainings.

**Greg Williams**—Greg came to Agri-Cycle in 2014 with diverse experience in the organics industry, including sales, consultation, business development, and operations. While completing a Master's in Community Planning & Development at the University of Southern Maine, he researched the feasibility of implementing a curbside organics program in Greater Portland. After receiving an award for this work from ecomaine, he presented to the Portland City Council in 2009. Williams successfully started and managed a commercial composting business with the City of Portland before joining Agri-Cycle.
