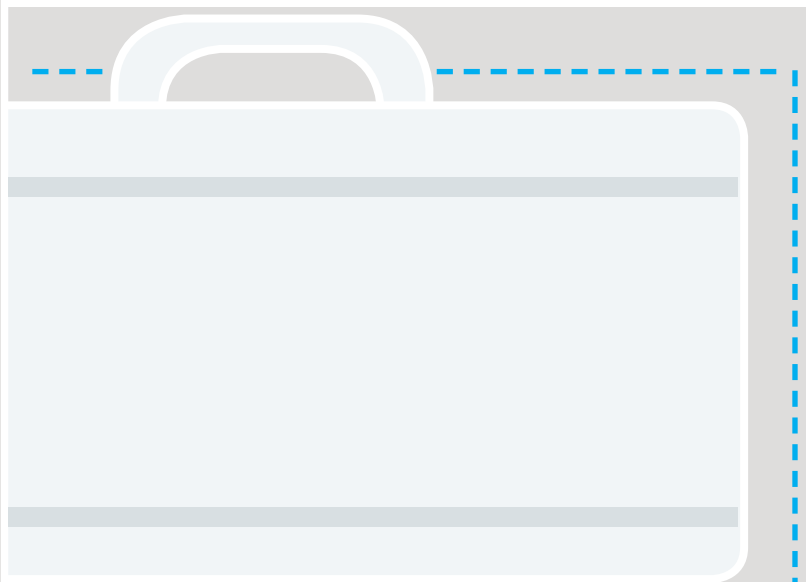

# 2018 Grant Funding
