## Membership Fees

### Full Member ~ \$35.00/year

One or more members of a family who are citizens or residents within the United States of America or Canada and are Full members of FHANA. The family must be in good standing with FHANA and adheres to our pure breeding guidelines in accordance with the KFPS/FHANA. For the purpose of this category, a family is defined as husband and/or wife or domestic partners and children under the age of eighteen (18) years. A family in good standing is entitled to one vote in SCFHA proceedings and one member of the family who is at least eighteen (18) years old is eligible for election to the Board. A Full member of another FHANA chapter may not be a Full member of the SCFHA. A Full member of SCFHA may be an Associate member of other FHANA chapter(s).

### Associate Member ~ \$25.00/year

Any person who has an interest in the Friesian horse, who is a FHANA member, non-FHANA member, an Associate member of FHANA, or is a Full or Associate member of another FHANA chapter can become an Associate Member of the SCFHA. An Associate Member is not entitled to vote in SCFHA proceedings, may not nominate someone to the Board, and is not eligible for election to the Board.
